35.36 B. Fees for Summons, Paper Service, Foreign Service and Subpoenas vary depending on the location – See Table A.

The papers are served throughout Lake County. Different types of papers require different procedures for successful service.

Definitions

Foreign Service – The delivery of a paper which originated outside of Lake County.

Subpoenas / Summons – A Subpoena or Summons is a paper issued by the court requiring a person to appear in court.

Other paper types may include, but not limited to:

Mental Health Writ – A mental health writ is an order from the court to take custody of a person and transport them to a mental health facility.

Body Attachment – A body attachment is an order issued by the court directing the authorities to bring before the court a person who has been found in civil contempt of court.
