*Luke Stowe explained this Resolution. (Member Nixon entered the meeting at this time)*

*Mr. Stowe then discussed how early voting is affecting the polling places on election day, stating that so many people voted early or absentee in the last election that it took the burden off of the polling places. Amy McEwan stated that election day runs much smoother now that there are site managers assigned to each polling place. (Member Paxton entered the meeting at this time)*

*Barry Burton reminded the Committee that early voting comes at a significant cost to the County. The Clerk's office will continue to look at the numbers of early voters and may be able to consolidate more polling places. Mr. Stowe will get a cost estimate of early voting to share with committee.*

*Amy McEwan reviewed the three stricken items that were discussed at last week's meeting, stating that they will revisit these items for next year's session. Member Nixon again expressed concern about removing the brownfield property late fee penalty and would like to see that added back into the program for this year. Barry Burton stated that he would like to see all three items on, but stated that if Speaker Madigan is not going to support these items, leaving them on could jeopardize other items. He suggested waiting a year and putting them on again next year.*

*Ms. McEwan stated that they are working on coming up with a way to charge a fee that will help offset the cost of operating the Sheriff's Marine Patrol. The cost is approximately \$650,000 a year, and we only get reimbursed \$45,000. She is working with the Fox Waterway Agency on this issue, but we are not ready to present a bill at this time.*

*Regarding the school inspection initiative, Mr. Burton stated that Representative Sid Mathias agreed to sponsor this, and they are working on modifying language for this bill.*

*Amy McEwan explained that the only amendment to the Federal Program is to include a request for \$1.5M in FY 2009 Health and Human Services Appropriations, Health Resources and Services administration funds to cover 5,494 specialty care and diagnostic testing referrals for 1,000 uninsured patients receiving care at HealthReach and the Lake County Health Department and Community Health Centers. This was inadvertently left off of the 2009 Federal Legislative Agenda.*
