Program Year 2025 (PY25) Opioid Response and Video Gaming Revenue (VGR) Applications Presentation - Discussion and Recommendations.

- The Behavioral Health Advisory and Recommendation Committee (ARC) is responsible for making funding allocation recommendations related to the Opioid Response applications and the VGR applications for the PY25 funding round.
- Recommendations are forwarded for consideration and approval to the Housing & Community Development Commission (HCDC).

Dominic Strezo, Community Development Administrator, reviewed the funding sources and process. The available funding sources include Video Gaming Revenue (VGR) and the Opioid Settlement Funds.

Courtney Cymerman, Grant Administrator, presented Video Gaming Revenue grant recommendations. Video Gaming Revenue applications were scored based on the following priorities: assessment, education, and outreach; clinical gambling addiction services; non-clinical gambling addiction services; and behavioral health services.

Penni Raphaelson, Grants Manager, presented recommendations for the Opioid Response Applications. The opioid settlement funds were partially allocated based on meeting the opioid response objectives of reducing fatal overdoses by 5% and non-fatal overdoses by 10% by April 2026 through strategies such as harm reduction, case management, system navigation, and recovery services.
