Joint resolution authorizing an emergency appropriation in the amount of \$951,350 for stream stabilization and a hydrological study.

- The Stormwater Management Commission was awarded \$951,350 through the USEPA Great Lakes Restoration Initiative (GLRI).
- \$832,850 will be used for 2,800 feet of stream restoration and best management practice installations in Winthrop Harbor.
- \$118,500 will be used for a hydrologic study of the Glen Flora Tributary in Waukegan.
- There is no match requirement.

Resolution on Zoning Case No. 3807, which consists of the petition of Combined Asset Development LLC, record owners, which seeks a rezoning of a 0.69 acre parcel from the Estate (E) zone to the General Commercial (GC) zone in Wauconda Township - District 5.

- The applicant desires to rezone the subject property from Estate (E) to General Commercial (GC) to continue operation of a red-tagged office for a tree service business located ¼ mile south of Route 176 adjacent to an on-ramp to Route 12.
- A valid protest petition has been filed with the County Clerk by the parcel's neighbor, requiring by law a favorable <sup>3</sup>/<sub>4</sub> vote of all members of the County Board to approve the requested rezoning.
- The ZBA recommends approval by a vote of 5-2; Planning, Building & Development Department recommends denial. See attached for further explanation.

Brad Denz and Dusty Powell, Planning, Building & Development, presented the staff's report on the zoning case, as well as, historical information concerning the property. Richard Nakon, attorney for the petitioner, and Shane Green, CEO of Homer Tree Service, presented the petitioner's case. Richard Bonk, neighboring property owner, described the petitioner's history of noncompliance. Chair Thomson-Carter noted that a valid legal objection had been filed on this case, necessitating a supermajority vote of the County Board for approval. She also noted that Member Gravenhorst was in compliance with the Electronic Participation Policy and was able to vote via telephone. Members in attendance concurred with this finding. Member Gravenhorst was disconnected from the meeting at 9:03 a.m.
