### 7.1 10-0802

Committee Action approving 2009 Brownfield Grants Requests for Extensions

- In 2009 the County awarded Brownfield Remediation Grants to Highland Park (\$100,000); North Chicago (two grants, \$100,000 and 50,000); and Lake Zurich (\$100,000). The applicants will not be able to complete their projects within the one year specified in the Intergovernmental Agreements and are requesting extensions.
- Written status reports have been submitted for all four projects and are attched.
- Representatives from the municipalities will present brief updates to the Committee and answer questions.
- If an extension is not granted for a particular project, the project will expire based on the
  date in the Intergovernmental Agreement. Unspent funds will be unencumbered and
  returned to the Brownfield Fund.

Neighborhood Stabilization Program (NSP) Update

- Lake County received \$4.6 million in Neighborhood Stabilization Program (NSP) funds to purchase and rehabilitate foreclosed homes
- By law, Lake County has until September 27 to obligate all of the funds or is at risk of losing them
- Staff will provide an update on the status of the obligation

## 7.4 <u>10-0665</u>

Joint resolution ratifying an emergency procurement authorized by the Winchester House Administrator with Leaderstat, 8181 Worthington Road, Westerville, Ohio for interim staffing services.

- In February, 2010 there was a need to secure interim nursing management positions of Director of Nursing, Assistant Director of Nursing and two Clinical Coordinators due to staff vacancies and the inability to find qualified candidates.
- In accordance with Article 6-103 of the Lake County Purchasing Ordinance, the Winchester House Administrator certified an emergency condition.
- The Purchasing Agent executed an interim staffing agreement.
- This is to ratify an emergency procurement authorized by the Winchester House Administrator with Leaderstat, 8181 Worthington Road, Westerville, Ohio in the amount of \$262,928 for interim staffing services for nursing management positions of Director of Nursing, Assistant Director of Nursing and two Clinical Coordinators.

## 7.5 <u>10-0840</u>

Joint resolution authorizing the Purchasing Agent to negotiate and enter into a contract with Forum Extended Care Services, Skokie, IL for Pharmaceuticals and Related Services for Winchester House for a two (2) year period with renewals in the estimated annual amount of \$350,000.

- Request for Proposals were called for by publication for Pharmaceuticals and Related Services for Winchester House.
- Requests for Proposals were extended to ten (10) firms and six (6) sealed proposals were received and opened on June 24, 2010.
- All responses were reviewed and two (2) finalists were interviewed.
- Based on the criteria set forth in the Request for Proposal, and the interviews, Winchester House Administration selected Forum Extended Care Services, Skokie, IL as the most favorable proposal for Lake County.
- This contract will cost the County an estimated annual amount of \$350,000 charging \$338,000 to account 218-4102010-62040-000-000-00000 and \$12,000 to 218-4102010-71150-000-000-000-00000.
