Committee action memo to approve the Spring 2020 Adopt-A-Highway Program.
- In accordance with the Lake County Adopt-A-Highway Ordinance, Spring open enrollment is between January 1 and January 31, and 51 applications have been received for the application period.
 - This volunteer program removes approximately 210,000 pounds of trash and debris from roadsides and bike paths annually.
 - Forty-three renewal group applications and eight new group applications were received during open enrollment.
 - Eighty-seven percent of the Adopt-A-Highway sections are currently adopted.
 - A listing of available Adopt-A-Highway sections, including an interactive map, can be found online at the Lake County Division of Transportation's website.
 - The Public Works, Planning and Transportation Committee must approve the allocation of roadway segments and the posted names for volunteer groups that have applied.
 - A staff report is provided regarding the applications received and

recommendations for allocation.

Ordinance requesting the conveyance of land rights for a permanent easement from the Village of Mundelein to Lake County for the purpose of replacing and maintaining an existing 36-inch diameter storm sewer.

- A 36-inch diameter storm sewer under Midlothian Road and adjacent private property is deteriorating and is scheduled to be replaced.
- The County needs to utilize an existing permanent easement granted to the Village of Mundelein (Document 1390467 recorded August 23, 1968) in order to construct the improvement.
- The Village is willing to quitclaim their interest in the permanent easement to the County for the construction of the improvement.
- This improvement is included in the highway improvement program, and designated as Section 17-00171-16-DR.

Joint resolution appropriating \$1,722,000 of Motor Fuel Tax funds for ice control salt materials needed for the 2020-2021 winter season.

- The Lake County Division of Transportation (LCDOT) will participate in the County's joint procurement process for the acquisition of ice control salt for the 2020-2021 winter season.
- Before a letting can be held, an appropriation of funds is required.
- This project is included in the highway improvement program and designated as Section 21-00000-05-GM.

Joint resolution authorizing a contract with Davey Resource Group, Inc., Elmhurst, Illinois, in the amount of \$47,105.90 for inspection and maintenance of recently planted native landscape areas along various County highways.

- The County has planted native landscape areas for various projects on the County highway system that require inspection and maintenance.
- This maintenance work will be done by a contractor.
- A total of three bids were received, ranging from \$47,105.90 to \$77,344, and the lowest responsible bidder is Davey Resource Group, Inc., in the amount of \$47,105.90 for the native landscape maintenance.
- This project is included in the highway improvement program, and designated as Section 20-00000-14-GM.

Joint resolution authorizing a contract with Campanella and Sons, Inc., Wadsworth, Illinois, in the amount of \$253,787.25 for the removal and replacement of storm sewer, curb, and gutter, with pavement milling and resurfacing on Wadsworth Road at Robert McClory Bike Path, and appropriating \$305,000 of County Bridge Tax funds.

- There was a public call for bids, and a total of three bids were received, ranging from \$253,787.25 to \$411,298.38, and the lowest responsible bidder is Campanella and Sons, Inc., in the amount of \$253,787.25.
- This project is included in the highway improvement program with construction scheduled to begin in 2020, and designated as Section 18-00055-07-SS.

Joint committee action item approving Change Order Number Three consisting of an increase of \$15,476.90 for additions to the Rollins Road sidewalk construction contract.

- Change Orders need to be approved by the standing committees for cumulative net increases over 10 percent.
- Rollins Road sidewalk project is under contract with A Lamp Concrete Contractors, Inc., Schaumburg, Illinois, in the amount of \$168,680.39 as approved by the County Board on May 8, 2018, and designated as Section 15-00999-20-SW.
- The contract included sidewalk and curb ramp improvements to meet current ADA standards, curb and gutter removal and replacement, roadway patching, minor drainage improvements, erosion control, thermoplastic pavement markings, landscaping and other related items.
- Change Order Number Three includes a final balancing of design quantities with measured field quantities for items such as landscaping, pavement markings, and temporary sidewalk aggregate.
- Change Order Number Two was for an additional quantity of earth excavation, concrete curb and gutter, asphalt surface, and detector loop replacement.
- Change Order Number One was for additional items necessary to complete the work such as drainage structures and traffic signal equipment items.
