Chief Engineer Matt Meyers of Planning, Building, and Development (PBD) addressed the committee regarding an amendment to an Intergovernmental Agreement (IGA) with the Village of Lindenhurst. The proposed amendment to the IGA will replace the current fee structure for the department's intergovernmental services with a fully loaded hourly rate fee structure.

## STORMWATER MANAGEMENT COMMISSION

## 8.2 <u>17-0658</u>

Joint committee action item approving the Stormwater Management Commission (SMC) applications to the IDNR - Coastal Management Program (CMP) and IEPA - 319 Water Quality Program grants for Lake Michigan watershed planning.

Mike Kinsela and Mike Prusila of Stormwater Management Commission (SMC) appeared before the committee to request permission to apply for two sources of grant funding for SMC. One from Illinois Department of Natural Resources (IDNR) - Costal Management Program (CMP) and one from Illinois Environmental Protection Agency (IEPA) - Section 319 Water Quality Program; both grants for Lake Michigan watershed planning. The applications will request funding to develop the plan, involve stakeholders and provide prioritized recommendations for stormwater infrastructure and water quality improvement projects throughout the entire watershed. SMC requests to be the grant applicant and contribute \$23,990 cash and \$22,000 of in-kind services. The grant funding would be used to reimburse SMC staff and consulting services for watershed planning tasks. Before the application could be submitted, SMC would need approval from PBZ and FAS. Discussion ensued.

A motion was made by Member Martini, seconded by Member Wilke, that this item be approved. Motion carried by voice vote.
