PUBLIC COMMENT

Public Comment was made by Rayon Edwards.

CHAIR'S REMARKS

Last month I met with some of the non-profits that do great work across Lake County, like Northern Illinois Food Bank. Last year in Lake County alone, 13.3 million meals were distributed via food pantries, soup kitchens, group homes, child-focused programs, and more. I was also able to meet with and observe Reading Power volunteers who work one-on-one with children to help them become better readers and writers. It was wonderful to speak to the volunteers about how much they enjoy it, which was very clear

to me as I saw the children happily reading and writing with their buddies.

I was also able to attend a ribbon cutting for a new Aspire home in Zion with Member Gina Roberts. Six adult people with disabilities live in this lovely home with the support of Aspire staff and volunteers, enabling them to attend local programs and work in and around their community.

I am grateful that I was able to join Member Diane Hewit and participate in a burial ceremony for indigent people who have passed away in Lake County. Coroner Jennifer Banek and the Lake County Coroner's Office, in conjunction with Catholic Cemeteries of the Archdiocese of Chicago, conducted Lake County's first Ecumenical Indigent Burial Ceremony at Ascension Cemetery in Libertyville. The cremated remains of 79 indigent or unclaimed people were interred in the cemetery. Funeral directors from throughout the county transported the remains from the coroner's office to the cemetery with an escort from the Lake County Sheriff's Office. It was a very nice ceremony.

As a member of the Access Lake board, I am pleased to announce that we continue to move forward with building our new, not-for-profit organization to enhance access to specialty care services for our uninsured Lake County residents. At our last board meeting, Mark Pfister was elected as Chair, Dr. Lee Francis, President and CEO of Erie Family Health as Vice-Chair, Pete Govorchin President of City of Hope is Secretary, and Matt Primack President of Advocate Condell as Treasurer. Marsha Oberrieder President of Northwestern Medicine Lake Forest Hospital was nominated and is now our Governance Committee Chair. We are currently seeking a fiscal agent to receive funding from the hospitals and other entities to support our work. Once we have a fiscal agent in place, we will begin the important work to improve specialty care access for our uninsured Lake County residents.
