7. NEW BUSINESS

UNIFIED DEVELOPMENT ORDINANCE

7.1 12-1032

Resolution on Zoning Board of Appeals Case No. 3746, which consists of the petition of RK123, LLC, RDDT Limited Partnership, General Partner DFFT-1, LLC, Robert and Constance Dimucci Trustees, which seeks a rezoning of a 108.79 acre parcel from the Estate (E) District to the General Commercial District (GC) in Ela Township - District 19.

Presented by Eric Waggoner, Director, Planning, Building and Development Department.

Chair Thomson-Carter opened the meeting to public comments, and announced that each individual would have five minutes to address the Committee. The public comment portion of the meeting was opened at 9:10 a.m.

Nancy McGranahan, resident representing Timberlake Civic Association, expressed concerns about the size of the proposed development, the increased traffic due to the development, light pollution from the development in the rural community, and the safety and security of the area residents.

Pam Newton, Chief Operating Officer for the Village of Hawthorn Woods, thanked the County for working with the Villages on refining the project and requested that

video-gaming be prohibited in the development.

Harry MacCartney, representing Active Citizens for Responsible Expansion (ACRE), Inc., expressed the concerns of the organization regarding the proposed development, to include the size of the development, traffic congestion, increased crime rate, and environmental factors impacting the community.

Keith Hunt, representing ACRE and Briarwood Estates Homeowner's Association, stated that the size of the development and the process through which the development was approved remain concerns of the area residents.

Bill Braithwaite, Attorney for the Village of North Barrington, withdrew his request to address the Committee.

Nancy Jacoby, resident of North Barrington, expressed her concerns regarding the impact of the proposed development on the active equestrian stables on Milton Road, and increased traffic along Milton Road.

Chair Thomson-Carter closed the public comment portion of the meeting at 9:40 a.m.

John DiMucci, applicant for the rezoning, provided an overview of the project.

Member Carey discussed with staff lighting questions, the availability of water to the proposed site, berms and landscaping around the site, and traffic control. She favored a 50' height limit for the project in lieu of the ZBA's recommendation of 40'. She also favored eliminating the ZBA's berm condition, and that the development can work to have a more visually attractive solution.

Members Carlson, Pedersen and Hewitt also noted their support for a 50' height limit and for eliminating the ZBA berm condition.

Vice-Chair Mountsier noted that increased traffic in the area would be addressed at the Final Plan stage and agreed with his colleagues to eliminate the ZBA's building height and berm conditions.

Craig Taylor, County Board Member representing the district in which the development is proposed, stated that his concerns regarding the proposed development have all been addressed. He supports the proposal.

Chair Thomson-Carter discussed lighting signage issues with staff, and noted that the project had significantly improved from the initial application.

Chair Thomson-Carter entertained a motion to combine Item 7.1 and Item 7.2 subject to include the conditions of the Zoning Board of Appeals (ZBA) Exhibit 1, increasing the 40' building height limit to be to 50' building height limit, and eliminating the berm condition established by the ZBA.

A motion was made by Member Carey, seconded by Vice-Chair Mountsier, that this resolution be recommended for adoption as amended to the regular agenda. The motion carried by the following vote:
