Departmental Presentation - Lake County Sheriff's Office.

Anthony Vega, Chief of Staff, Sheriff's Department, gave an overview of the events in Lake County over the previous days. Last week the nation witnessed the death of George Floyd while in the custody of Minneapolis police which has created demonstrations and protests. On Sunday there was a peaceful protest which later transitioned to looting in Waukegan and Beach Park. The Waukegan police department worked with the Sheriff's Department. During the night five Sheriff's Office squad cars sustained significant damage but no personnel were injured. The Sheriff and local municipalities departments continue to monitor the situation. The Sheriff's department thanked Chair Hart and the County Administrator's Office for their support and efforts over the last few days.

Chief Vega gave the annual update to the Committee. The department has achieved their long time strategic goals. The focus was in five distinct areas: Community Relations, Communications, Workforce Planning, Career and Professional Development, and Positive Employee Relations. An important component is training. They will be looking at grants to achieve the long term goals. When Sheriff Idleberg joined the department the technology was very old. Systems have been updated but more is needed to be done. The Sheriff is committed to the 911 consolidation. This is one of the most important programs.

Chief Vega also mentioned there are no more COVID-19 positive inmates currently in the jail. Although with the increase in inmates, there will not be room to isolate any inmates who do become positive. Discussion ensued.

Chair Hart thanked the Sheriff's Office and the work they did for everyone's safety during the protests. She also read part of Sheriff's Idleberg's announcement to Lake County. Vice Chair Cunningham also thanked Sheriff Idleberg and the Sheriff's Office.

Sheriff Idleberg thanked the Board and stated he looked forward to working with them in the future.

PUBLIC DEFENDER

Departmental Presentation - Public Defender.

Joy Gossman, Public Defender's Office, provided the annual update. The Public Defender provides legal representation for adults and minors charged with criminal defenses. The Public Defender's Office also represents respondents in mental health petitions and medication compliance patients of which there has been increase. There are 47 employees in the department including attorneys, private investigators and social workers. The case appointments have dropped but during the summer they tend to go up. There has been an increase in abuse and neglect cases. There are 21 murder cases pending (which is high). The staff are in fourteen different courtrooms throughout a day. Currently, the Public Defender's Office has been using Zoom for court cases during the pandemic.

Jim Hawkins, Deputy County Administrator, stated the 911 consolidated request proposal is moving along.

Member Barr thanked the Sheriff's Department and all the municipal police departments for keeping everyone safe. He had a question for the Sheriff's Department asking if the individuals were out of the area who were looting.
