Ordinance amending the Lake County Liquor Control Ordinance.

- The Lake County Board adopted the Lake County Liquor Control Ordinance for unincorporated Lake County on February 14, 1984.
- A schedule of license application and renewal fees is included in the ordinance.
- The Liquor Control Commissioner has recognized the significant startup costs associated with establishing a new business.
- The Commissioner recommends prorating the renewal fee for first time applicants, based on the number of months remaining in the license year.
- Amendments to the ordinance are necessary to establish the proration and associated housekeeping changes.

PLANNING, BUILDING AND ZONING COMMITTEE

18 <u>14-0315</u>

Joint resolution authorizing a contract with Berry Dunn, Portland, Maine, in an amount not to exceed \$126,056 for a needs assessment and to develop requirements for the replacement of the land management, code enforcement and permitting service systems for Lake County.

- The County's Land Advisory Team (LAT), comprised of the County's Division of Transportation, Health, Information Technology, Planning, Building and Development, Public Works, and Stormwater Management Commission Departments, coordinates the integrated land development process for the County.
- The process of land management, code enforcement and permitting is presently conducted through the use of multiple systems, with a number currently reaching end of life
- It is the desire of the County to ultimately procure a new land development system in cooperation with a number of County municipalities; selected based on a full need assessment.
- The Request for Proposal (RFP) was developed and reviewed by an interdepartmental committee comprised of a representative from each of the LAT departments, in addition to two municipal representatives (Lake Forest and Round Lake Beach).
- This potential system replacement effort will involve a review of the County's and our
 municipal partners' present processes with an eye on improving the efficiency of land
 development operations for which a consultant is needed to review the County's need,
 the current state of offerings compared with best practices, and make
 recommendations to improve County and municipal operations.

- The RFP was sent to 26 vendors with proposals received from five non-local vendors; no local vendors submitted a proposal for this service.
- Based on the criteria set forth in the RFP for consulting services for a needs
 assessment and requirements for the replacement of the land management, code
 enforcement and permitting services for Lake County, Berry Dunn is the most qualified
 and most favorable vendor.
- The contract includes consulting services at a contract amount not to exceed \$126,056.

LAW AND JUDICIAL COMMITTEE

19 <u>14-0277</u>

Joint resolution authorizing execution of an agreement with Current Technologies Corporation, Downers Grove, Illinois to provide a Public Safety Microwave Network for Lake County Emergency Telephone System Board (ETSB) in an amount not to exceed \$344.022.84.

- The Lake County Emergency Telephone System Board (ETSB) is currently utilizing VPLS Fiber Connection approved by the Lake County Board in October 2012.
- The new microwave system will increase reliability of data communication, provide high bandwidth for transmission of mission critical data, enable secure and reliable communication for the 911 Next-Gen phone system and Computer Aided Dispatch (CAD) system and allow for expansion of shared services across the communication platform.
- A Request for Proposal (RFP) was issued for a turnkey system that provided for the
 configuration, installation, monitoring and maintenance of a new public safety microwave
 system backbone network with a physical ring topology to the respective Public Safety
 Answering Point (PSAP) within Lake County.
- The RFP was sent to 42 vendors and proposals were received from eight firms.
- A selection committee comprised of staff from the ETSB Technology Committee and Purchasing Division recommend the services of Current Technologies Corporation, Downers Grove, Illinois as the firm who best meets the needs of the County based on the RFP evaluation criteria.
- The ETSB approved this purchase on March 4, 2014.
- The contract includes configuration, installation monitoring and maintenance at a contract amount of \$344,022.84 with an ongoing annual software maintenance cost estimated at \$33,450 for years two and three and \$35,550 for years four and five.

Joint resolution ratifying an emergency procurement in the amount of \$95,950 with Water Well Solutions Illinois Division, LLC of Lake Villa, Illinois for emergency repairs to Well #6 for the Pekara Water System.

- Well #6 provides water supply to the Pekara Water System that serves approximately 1,200 homes and some commercial properties in the unincorporated areas of Pekara, adjacent to the Village of Buffalo Grove.
- Public Works identified a premature well failure and emergency repairs were needed to
 ensure sufficient water supply to meet demand during peak water days for spring and
 summer months.

- Pursuant to the Lake County Purchasing Ordinance, emergency procurements are made when a threat exists to public health, welfare, or safety, or to prevent or minimize serious disruption of government services.
