Unclaimed Bodies – 2018 Statistical Breakdown

The Lake County Coroner's Office made the removal of 28 decedents from Nursing Homes, Hospital and Residence that either had no family, were UNCLAIMED by family or family did not have a Funeral Home at time of death. This is only an increase of 1 from 2017. 6 of the 28 cases were UNCLAIMED Veterans an increase of 100% from 2017. There was a 71.4% increase in State Public Aid cases and County Cremations from 2017. The number of non-coroner case removals of unclaimed bodies from nursing homes and hospitals increased by 200% from 2017 and the number of non-coroner case removals from residence decreased by 77.3 %. The Lake County Coroner's Office staff was able to work with 11 families to provide disposition with an average of 60-90 days of storage in the county morgue. There is 1 UNIDENTIFIED body which is pending FBI DNA Analysis.
