Petitioner's Testimony

Christopher J. Cahill, applicant, testified the following: he owns the lot to the north and two adjacent lots to the south of the area of Olive Street that is the subject of the proposed vacation request; the second applicant, Leon LaJeunesse, owns the south lot adjacent to the area of Olive Street that is the subject of the proposed vacation request.

Board Comments/Questions

Member Steffen raised questions about the driveway apron belonging to Leon LaJeunesse and if that area would belong to Mr. Cahill. The applicant, Christopher J. Cahill, stated that the area with the driveway will be transferred to Mr. LaJeunesse via quit-claim deed. Member Duckert asked why the applicants did not also include the unimproved right-of-way located to the east of Mr. Cahill's property abutting property owned by the Lake County Forest Preserve. Mr. Cahill stated that area slopes downwards, and he did not need that section of right-of way.

A member of the public asked if there was a sewer line that would be impacted. Jeff Shrei, Lake County Health Department, answered that there is no sewer line in the area.

1. A vacation of the subject portion of Olive Street will have no negative impact on the general public or public infrastructure.
