Illinois Youth Survey

The Illinois Youth Survey (IYS) is offered every even numbered year through the Center for Prevention Research and Development at the University of Illinois.

The IYS is a self-report survey administered in school settings and is designed to

gather information about a variety of health and social indicators including substance use patterns and attitudes of Illinois youth.

Prevention specialists at the Lake County Health Department work with Lake County Middle and High Schools to help them register and administer this survey.

For this 2016 survey year:

63 out of 79 eligible schools (schools with 20 or more students per grade) took the Illinois Youth Survey resulting in 78% of Lake County schools taking the survey.

This is a 16% increase from 2014

12,997 10th and 12th grade students took the Illinois Youth Survey resulting in 66% of 10th and 12th grade students surveyed.

This is an 18% increase from 2014

The Health Department thanks all the schools who participated this survey year as this is a very important data source about our Lake County children. These results will help prevention specialists identify areas in need of focused intervention surrounding issues such as substance use prevention in Lake County.

National Preparedness Month

September is recognized as National Preparedness Month, which serves as a reminder that we all must take action to prepare, now and throughout the year, for the types of emergencies that could affect us where we live, work, and also where we visit.

Suicide Awareness Walk

More than 200 people participated in the annual "Wauk" for Awareness 5K which took place in Beach Park on August 27.

Organized by the Waukegan Cares Foundation, the event raised approximately \$8,500 for several organizations that are building awareness about suicide, including the Lake County Suicide Prevention Task Force, which meets monthly at the Health Department.

We just received confirmation of the first human case of WNV in Lake County and here are a few bullets.

The first confirmed human case of West Nile virus in Lake County in 2016 is a resident of Ingleside who was hospitalized in late August and discharged in early September.

Eighty-four (84) pools (batches) of mosquitoes and two birds have tested positive for West Nile virus in the county thus far this year.

The Health Department is continuing to urge people to take precautions against mosquito bites as this is the time of year when we see human cases of West Nile virus

and although the weather is getting cooler, mosquitoes will remain active until the first hard freeze.

We encourage people to stay active outdoors, but please remember to wear insect repellent and take other precautions to avoid mosquito bites.

*LAKE COUNTY PARTNERS COUNTY BOARD UPDATE
SEPTEMBER 2016*

Lake County Partners' quarterly Board of Governors meeting was hosted by Takeda Pharmaceuticals in Deerfield on September 8th. The Board welcomed three new members: Libby Brunsvold of Takeda Pharmaceuticals, Donald Hansen of Grainger and Damon Havill of Advocate Condell Medical Center. Information was presented on a number of topics, and it was very positive:

The Lake County "Workforce Ecosystem" partnership continues to strengthen, and the major workforce stakeholders in the County are now successfully plugged into a single customer relations management platform (Salesforce.com) to optimize interactions with local businesses and ensure they have the tools that they need to succeed. As a result, Lake County Partners has made 29 connections between businesses and partners such as the College of Lake County and the Lake County Workforce Development Department.

Data indicates that, in Lake County: 1) the unemployment rate has remained low and is now at 4.9%; 2) the labor pool is growing and Lake County has added 1,755 workers over the last year which has resulted in a labor force participation rate of over 70%; 3) average wages are increasing; 4) job counts are back to pre-recession levels in key sectors/target industries; and, 5) the vacancy rates for industrial, office and retail space have continued to decrease.

Lake County Partners recently surveyed municipal investors and received favorable feedback on the expanded municipal services, and so they will continue into 2017. The services include a quarterly lunch workshop at the University Center, a sponsored booth for municipal investors at the International Council of Shopping Centers (ICSC) Chicago Deal Making Show, and regular data reports. Lake County Partners now generates over 1,600 customized data reports for municipal investors each year, and municipalities use the information to communicate with site selectors, brokers, developers and elected officials and advance their economic development initiatives.
