**ACTION REQUESTED: Approval**

Bleck Engineering Co. is currently performing various engineering and related tasks on thirteen projects (see list below) for SMC under our Professional Services Agreement (Agreement) approved on April 7, 2022. The Agreement is for a not-to-exceed amount of \$531,312.90 (T&M basis) through April 6, 2024. The current projects total \$465,670.55, leaving a balance of \$65,642.35.

Staff requests approval to expand Bleck's current Service Requests #13. The not-to-exceed total costs for #13 are \$223,590.00. SR #13 will be reimbursed by DCEO Round 1 grant engineering expenses.

Your approval is requested to increase the not-to-exceed amount in the Agreement to \$689,260.55 to cover the engineering project costs for SR #13.
