Approval of CDBG-PS & ESG Application Scoring Criteria

- After last year's application process, staff was directed to develop revised scoring criteria for the CDBG-Public Services and Emergency Shelter Grant applications.
- The proposed revisions are intended to be more driven by objective formulas to ensure equitable review.
- Staff seeks Commission approval of the scoring criteria.

Scoring Criteria - REVISED

Mr. Joel Williams explained the proposed revisions to the Public Services (PS) and

Emergency Shelter Grant (ESG) applications' scoring criteria, derived in response to questions following last year's review process. In order to provide greater transparency, the major proposed scoring revision would utilize objective formulas to determine 64% of each applicant's possible points, with the remaining 36% assigned by each Application Review Committee (ARC) member. In previous years, formulas were used to determine 5 – 15% of the available review points. Mr. Williams presented an overview of the criteria upon which the points would be awarded. A lengthy discussion about objectivity versus subjectivity ensued.

A motion was made to amend the revised application scoring criteria, to allow 50% objective scoring by formula and 50% by subjectivity.

Motion failed, with Members Calabresa, Cunningham, Ditzig, Hewitt, Krapf, Mancino, Molek, Northern, Pedersen, Rose and Swartz voting nay, and Members Russell, Swanson and Venturi voting aye.

A motion was then made to approve the item as presented.

Upon the motion failing, the CDC directed Staff to run the objective formulas, at both the 64% – 36% and the 50% – 50% levels, in tandem with the current criteria, and then present the comparisons of the final outcomes at a future meeting. The CDC requested that further evaluations of the criteria be scheduled over several meetings, beginning in March of 2012.

A motion was made by Commissioner Calabresa, seconded by Commissioner Molek, that the item be approved. Motion failed by the following vote:
