### INTERGOVERNMENTAL AGREEMENT BETWEEN THE COUNTY OF LAKE, ILLINOIS AND PACE THE SUBURBAN BUS DIVISION OF THE REGIONAL TRANSPORTATION AUTHORITY Amendment #1

This amendment (the "Amendment") is made by <u>the County of Lake (hereinafter referred</u> to as "COUNTY") and <u>Suburban Bus Division of the Regional Transportation Authority</u> (<u>hereinafter referred to as "PACE"</u>), parties to the agreement (the "Agreement") dated January 1, 2012 and amended this \_\_\_\_\_ day of \_\_\_\_\_, 2012.

The Agreement is amended as follows:

Exhibit A (Service Description) has been revised to:

- Expand the NW Demo Project current geographic service area to include the Townships of Wauconda and Fremont as a destination based service three days a week, to the following destinations: the College of Lake County, Gurnee Mills Extension, and the Greenleaf Medical offices.
- Include the designated destination of the Greenleaf Medical offices during the hours of 9:30am to 2:30pm on Mondays, Wednesdays and Fridays for registered riders of the Townships of Antioch, Avon, Grant, and Lake Villa, as detailed in Exhibit

A. The amended service descriptions (Exhibit A) shall be effective August 17, 2012.

Exhibit B (Service Area Maps) has been revised to include Wauconda Township and Fremont Township and the proposed destinations to the College of Lake County, Gurnee Mills Extension, and the Greenleaf Medical offices.

The revised Exhibit A and Exhibit B attached to the Amendment shall replace Exhibit A and Exhibit B of the Agreement.

Except as set forth in this Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms. If there is conflict between this amendment and the Agreement or any earlier amendment, the terms of this amendment will prevail.




#### EXHIBIT A SERVICE DESCRIPTION LAKE COUNTY NORTHWEST DEMONSTRATION PROJECT

TYPE OF	Demand response <b>curb to curb</b> paratransit services. Three accessible
SERVICE	paratransit buses will be added to existing Dial A Ride (DAR) services to accommodate expansion.
SERVICE OPERATED BY	Pace will contract with transportation provider(s) (the "Contractor") to provide the service which is the subject of this Agreement.

TRIP RESERVATION METHOD	Monday through Friday 6:00am to 7:00pm. Sunday 8:00am to 5:00pm
	Phone reservations are taken <b>one</b> (1) day in advance.
	Passengers may make seven (7) day advance reservations for work and medical appointments only.
	Guaranteed trip for NFI participant: Participant must make reservation one day in advance by <b>12:00 noon Monday thru Friday</b> to be guaranteed a trip.

	Residents of the four Northwest Townships of Antioch Township, Avon Township, Grant Township, and Lake Villa Township may travel to commercial/retail locations in the Gurnee Mills area in an effort to connect people with jobs. See Exhibit B Maps for service boundaries.
	Residents of the six Northwest Townships of Antioch Township, Avon Township, Grant Township, Lake Villa Township, Wauconda Township, and Freemont Township may utilize the destination based service for during a five hour window on designated days to the following locations: the College of Lake County (CLC), the Gurnee

	Mills Extension, and the Greenleaf Ave. medical office. See Exhibit B Maps for service boundaries.
	The three buses shall be added to the current Northwest Lake DAR service when not operating in the above described service.
SERVICE HOURS	Trips originating and terminating within Antioch Township, Avon Township, Grant Township, and Lake Villa Township may travel between 5:30AM to 6:45PM Monday through Friday.
	The first scheduled pick-up time for the NW Demonstration DAR is 5:30am and the last scheduled pick-up time is 6:45pm
	Trips originating within Antioch Township, Avon Township, Grant Township, Lake Villa Township, Wauconda Township, and Fremont Township going to the Gurnee Mills area, Greenleaf Medical offices, and the College of Lake County may only travel as a destination based service between 9:30 AM to 2:30PM Monday, Wednesday, and Friday Except for the following holidays on the days observed:
	New Years Day, Memorial Day, 4 <sup>th</sup> of July, Labor Day, Thanksgiving Day and Christmas Day.
ONE-WAY FARE	<b>\$2.00</b> Flat Fare for Disabled and Senior passengers. Seniors are defined as passengers age 65 and over.
	<b>\$4.00</b> Flat Fare for General Public
	<b>COMPANIONS:</b> Companions pay full fare. Companions limited to vehicle capacity. This includes children of all ages
	Fare tickets may be provided and reimbursed by project sponsors.
RIDER ELIGIBILITY	The participating sponsors of Antioch Township, Grant Township, Lake Villa Township, Avon Township, Waconda Township, and Fremont Township or designee(s) assigned shall determine rider eligibility.
	Programs eligible: NFI; Other as determined by sponsors
RIDER REGISTRATION FOR SERVICE	The participating sponsors shall submit registration forms to Pace through a designated e-mail box. Pace shall enter registrations within three to five business days. Pace shall maintain a database of registered riders. Riders must be registered for service.
















#### **GREENLEAF MEDICAL OFFICES BOUNDARIES – SOUTH**
