- A request to have the County form an SSA for construction of a sanitary sewer system has been submitted by the Forest Haven Home Owners Association for 111 homes.
- This request included preparation of a second petition by the homeowners for this project and preliminary cost information developed for this SSA was used to prepare a proposing ordinance.
- This ordinance proposes establishment of an SSA to fund the construction of a sanitary sewer system, establishes the maximum amount of bonds that may be issued, establishes the maximum annual property tax that may be levied per lot, establishes the maximum number of years taxes may be levied as thirty (30) years, and sets the date, time, and location for the public hearing to consider establishment of the Forest Haven SSA.
- The public hearing will be conducted by a subset of the County Board which will include the Board Chair, the members of the Public Works and Transportation Committee, and the County Board member in whose district the SSA resides.
- The public hearing will be held on April 15, 2010 at 7:00 PM at the St. Basil Serbian Orthodox Church, 27450 N. Bradley Road, Mettawa, Illinois 60045.
- This Ordinance proposes the formation of SSA #15 and if an objection petition signed by

at least fifty-one percent (51%) of the electors within the SSA territory and at least fifty-one percent (51%) of the owners of record of property within the SSA territory is not received within the 60 days following the adjournment of the public hearing then this SSA may be established, and an Establishing Ordinance would then be submitted for such action.

- The goals of the program include creating jobs, serving victims of crime, and assisting in the prosecution of violent offenders.
- The program is 100% funded by ARRA, with no local match required and will support 36 months of salary, fringe and administrative expenses of a Victim Witness Counselor position to be housed in the State's Attorney's Office.
- The new Victim Witness Counselor will serve misdemeanor domestic violence victims and will assist as necessary in serving aggravated battery, cyber crime, identity theft and fraud victims.
