Novel Coronavirus (COVID-19) Updates:

The United States continues to be the epicenter of the COVID-19 pandemic, with over 6 million cases and 185,000 deaths. In Lake County, we have had over 14,500 confirmed cases and over 450 confirmed deaths.

Last week, based on weekly metrics determined by the Illinois Department of Public Health, Lake County's risk designation changed to 'orange' – indicating warning signs of increased COVID-19 risk.

This change in the risk level was prompted by increasing case rates and deaths in Lake County between August 23-29. Infections among people ages 19-25, including at Naval Station Great Lakes, have driven the rise in cases in recent weeks.

Since August 17, the Health Department has been investigating 24 COVID-19 outbreaks in a variety of settings. At least 30 outbreak-related cases were linked to just three private gatherings. It is very important to remember to follow the 3 Ws even when around trusted friends, family, and co-workers: Wear a mask, Wash your hands, and Watch your distance. On August 28, the Health Department launched a School Decision Dashboard with data to inform school superintendents' decisions to pursue in-person, hybrid, or in-person learning. The dashboard is available at www.lakecountyil.gov/c19schools.

The Health Department continues to work with businesses and many other facets of the community to prevent and control the spread of COVID-19. For more information, please visit the Lake County Coronavirus website, www.lakecountyil.gov/coronavirus.

### Contact Tracing

The Health Department continues in its efforts to build the county's contact tracing workforce. As of August 31, 54 out of 154 planned positions have been filled. Funding for these positions is being provided through a \$4.9 million dollar grant from the state, and through partnerships with Lake County Workforce Development and the CDC Foundation.

Get Your Flu Vaccine

During the COVID-19 pandemic, reducing the spread of respiratory illnesses like

influenza, or flu, is more important than ever. The Centers for Disease Control and Prevention (CDC) has worked with vaccine manufacturers to have extra flu vaccine available this flu season.

CDC recommends that everyone over the age of 6 months get a flu vaccination every year. Now is the ideal time to get vaccinated so you are protected through the fall and winter months.

Many healthcare providers and retail locations have flu vaccine available. Contact your doctor or visit vaccinefinder.org to find a location near you.

#### Rabies Prevention

Animal Care and Control has received two positive rabies results from bats collected in Grayslake and unincorporated Antioch.

As of September 1, 46 bats have been tested this year. Between 3-4% of bats submitted for testing are positive for rabies. People who are exposed to a rabid bat must receive prophylactic rabies treatment and their pets may be quarantined for up to 6 months. Animal Care and Control staff are on call 24 hours a day and respond to capture bats found within the living quarters of a residents' home. Submission for rabies testing is based on exposure type, and not all bats captured are tested.

#### Suicide is Preventable

Feelings of isolation, depression, anxiety, and other emotional or financial stresses are known to raise the risk for suicide. People may be more likely to experience these feelings during a crisis like the COVID-19 pandemic.

Suicide is preventable. Evidence shows that providing support services, talking about suicide, reducing access to means of self-harm, and following up with loved ones are just some of the actions we can all take to help others.

Continue to Protect Yourself from Mosquitoes

The Health Department monitors and tests mosquito populations for West Nile virus (WNV) each year in coordination with a mosquito abaterment company, Clarke, and the Lake County Forest Preserves District. Mosquito trapping will conclude on October 1. As of August 26, a total of 61 'pool' or batches of mosquitoes, have tested positive for West Nile virus (WNV). While this is above average for this time year, it does not indicate high levels of WNV in Lake County.

Expect mosquito activity to continue in Lake County until the first hard frost. Take precautions to "Fight the Bite" by practicing the Ds of Defense – Drain standing water around your home, Defend with an EPA-certified insect repellent, Dress in long sleeves and pants, and be extra cautious at Dawn and Dusk, when mosquito activity is at its peak.
