Resolution authorizing a contract with KJWW Engineering Consultants, PC of Chicago, Illinois for engineering design services to replace the fire alarm system for Division of Transportation buildings in Libertyville, IL.

- There is a need to retain a qualified engineering firm to provide engineering services to replace the fire alarm system for the Division of Transportation buildings in Libertyville.
- Lake County has a satisfactory relationship with KJWW Engineering Consultants PC of Chicago, Illinois on similar work.
- Facilities Management staff received a proposal from KJWW Engineering Consultants, PC for the provision of code review and design services, production of construction bidding documents, bidding assistance and construction administrative services and negotiated a fixed fee contract in the amount of \$64,500 plus reimbursables.
- It is in the best interest of the County to enter into a contract with KJWW Engineering of Chicago, Illinois.
- This contract for engineering services is being made in accordance with Section 5-101(3) of the Lake County Purchasing Ordinance and the Local Government Professional Services Selection Act (50 ILCS 510/1 et seq).
- The contract will be charged to account 101-1103285-71150-000-000-000-11155.

20. **09-2074**

Resolution authorizing the Purchasing Agent to enter into a two (2) year contract with three (3) additional one (1) year renewal options with PAETEC, Chicago, Illinois, for Land Line, ISDN-PRI Services in the estimated amount of \$79,111.

- Lake County desires to enter into a contract for Land Line, ISDN-PRI Services.
- Invitations for bids were called for by publication and extended to (14) potential suppliers; nine (9) sealed bids were received from seven (7) suppliers and opened on September 2, 2009.
- The Information Technology Department evaluated all bids.
- The other bids received ranged from \$96,480 to \$234,996.

- PAETEC is the lowest, responsive and responsible bidder in the estimated amount of \$79,111 for a two (2) year contract, charging to account 101-1300020-71940-13050.

Health and Community Services Committee

21. 09-2013

Joint resolution authorizing an amendment to the intergovernmental agreement with the City of North Chicago to extend the timeframe for the expenditure of 2008 Brownfield Funds.

- In October 2008 the County Board executed an intergovernmental agreement with the City of North Chicago for a Brownfield Grant for up to \$100,000 for clean-up activities at the Northwest Corner of Sheridan Road and Martin Luther King Drive in order to redevelop the downtown area.
- To date, the County has reimbursed the City \$68,000 for remediation activities performed under this grant.
- The Resolution would authorize an amendment to the intergovernmental agreement with North Chicago to extend the timeframe for the City to request reimbursement of the remaining \$32,000 in Brownfield Funds from October 2009 until October 2010.

Joint resolution to execute the necessary documents to submit the 2009 Continuum of Care Homeless Assistance Application.

- The U.S. Department of Housing and Urban Development (HUD) announced the availability of approximately \$1.43 billion for homeless assistance programs, of which Lake County is eligible to apply for at least \$1,301,566 with potential bonuses totaling an additional \$157,954.
- Since 1998, Lake County has assumed a leadership role in organizing the homeless assistance planning process required under the Continuum of Care (CoC) and the County annually submits an application for homeless assistance funding.
- Lake County's Advisory Planning Group (APG), comprised of over 20 homeless service providers, government entities, homeless and formerly homeless persons, and other human service agencies will develop the funding recommendations for FY09 Continuum of Care funds.
- The Community Development Commission (CDC), which has been overseeing this process, meets the evening of October 28. This resolution is contingent upon the CDC approving the funding recommendations.
- The final Continuum of Care application must be submitted to HUD by November 9, 2009.

23. 09-2012

Joint resolution to enter into an agreement with Integrity Developers, Inc. for an Incumbent Worker Training Grant for a total cost of \$17,500.

- In response to outreach efforts, Integrity Developers, Inc. expressed interest in the incumbent worker training program. Integrity Developers, Inc. line of business is construction that involves rehabbing & remodeling, additions & build outs, design, project management, concrete & asphalt paving, new homes and retail & commercial building. Integrity Developers, Inc. has increased employees from 3 to 5 in less than a year, are

located in Waukegan, and has been in business for over 2 1/2 years.

- After consultation with Integrity Developers, Inc. a training solutions curriculum was prepared to train 4 Integrity Developers, Inc. employees for a total of 200 training hours to learn the financial aspects of the day to day operations which include accounting, payroll and budgeting systems and setup.
- The state policy requires that an employer with 50 or less employees provide 10% of the cost of the training. The policy also states that employee wages & fringes can be used to off-set the employer match without the employer having to pay additional funds out of pocket.
- The total cost of training is \$17,500. Lake County Workforce Development will reimburse Integrity Developers, Inc. \$17,500 and the company will provide employee hourly wages of an additional \$1,750 to show for their portion of the match. Cost per employee is \$4,375 for 50 hours training for each employee.

Law and Judicial Committee

24. 09-2010

Joint resolution authorizing the acceptance of interagency agreement #209059 with the Illinois Criminal Justice Information Authority to provide federal funding of \$31,790 for the Children's Advocacy Center Bilingual Victim Advocate for an additional twelve months, covering the period October 1, 2009 through September 30, 2010.

- In 1999, the Children's Advocacy Center implemented this grant for a bilingual victim advocate. The victim advocate provides comprehensive supportive services to child victims and their non-offending family members throughout the court process.
- This grant funds part of the salary of the victim advocate, and contributes to a small portion of program expenses. The grant does not fund fringe benefit expenses.
- The Children's Advocacy Center funds the match (20%) and overmatch by reimbursing the State's Attorney's Office. Sources of program funding include \$31,790 in federal funds toward salary, a 20% required match of \$7,948 toward salary, and an overmatch of \$32,428 toward salary and fringe for the position for a total of \$72,166.
- The position's salary during the grant fiscal year is estimated at \$54,635 and fringe expenses are estimated at \$17,531 for a total of \$72,166.

Joint resolution authorizing the acceptance of the renewal of interagency agreement with the Illinois Criminal Justice Information Authority, agreement #209315, to provide federal funding of \$48,550 for the Children's Advocacy Center Victim Advocate for an additional twelve months, covering the period October 1, 2009 through September 30, 2010.

- In 1999, the Children's Advocacy Center implemented this grant for a victim advocate. The victim advocate provides comprehensive supportive services to child victims and their non-offending family members throughout the court process.
- Program Goals include: funding for a victim advocate who is dedicated to providing services for child victims of abuse and their non-offending family members; prevention of re-victimization of children through education and emotional support; and maintaining the current staff of victim advocates in order to provide efficient services to abused children.
- The Children Advocacy Center has served an average of 511 victims and non-offending family each year over the last seven years
- This grant funds a portion of the salary of the victim advocate, and contributes to a small portion of program expenses. The grant does not fund fringe benefit expenses.
- The Children's Advocacy Center funds the required match (20%) and overmatch by

reimbursing the State's Attorney's Office.

- Sources of Program Funding include \$48,550 in federal funds for salary, \$12,137 for the 20% required match for salary, and \$20,557 in overmatch for salary and fringe for a total of \$81,244.
- Program expenses during the grant fiscal year are estimated at \$62,278 in salary and \$18,966 in fringe for a total of \$81,244.

Resolution amending and designating the voting sites assigned to the 481 voting precincts in Lake County townships.

- Precinct voting sites countywide are being consolidated into multiple precinct voting sites due to increased voting options such as early voting, no excuse absentee voting, and grace period voting.
- These consolidations will help offset increased costs due to newly mandated voting options.
- Relocates precincts to voting sites which have sufficient parking and space as well as full accessibility for all voters. Additionally, a few sites are no longer available to serve as voting sites (declined, renovation, etc.) requiring a new location for these precincts.

- The duration of the contract construction has expanded due to the unexpected length of time required for ComEd and Union Pacific Railroad to review plans and work methods.
- Alignment changes during construction were made to address the requirements of ComEd and to address concerns raised by Lake Forest open lands.
- This supplemental appropriation of \$15,000 of Motor Fuel Tax fund is needed to cover consultant change order # 1 & final which totals \$25,685.

Joint resolution appropriating a supplemental amount of \$100,000 of County Bridge Tax funds for the resurfacing of the Stearns School Road Bridge deck and designated Section 07-00236-02-BR.

- Stearns School Road Bridge Deck Resurfacing: Supplemental Appropriation
- Construction costs increased due to protective shielding to prevent items being dropped onto I-94 as the extent of deck repairs has changed.
- This supplemental appropriation of \$100,000 from the County Bridge Tax fund is needed to cover change order No. 1.

Your Department of Planning, Building and Development has recommended that these amendments be adopted; on the motion to adopt the proposed text changes attached as Exhibit A, your Zoning Board of Appeals vote is 6 "Ayes" and 0 "Nays"; the Planning, Building and Zoning Committee recommends by a vote of 7 "Ayes" and 0 "Nays" the amendments attached as Exhibit A, as amended by Exhibit B, be adopted.

- Following an initial Planning, Building and Zoning Committee review, the County Board directed the Zoning Board of Appeals on August 11, 2009 to conduct a public hearing on a series of proposed Amendments to the Unified Development Ordinance (UDO).
- A majority of the proposed amendments are "Housekeeping" amendments that either clarify or introduce minor changes to the current UDO provisions. "Substantive" amendments include the introduction of the R-4A Zoning District, introduction of landscaping-related Best Management Practices and Low Impact Development, and limited retail sales events for Wholesale Nursery Operations.
- At the conclusion of the public hearing on September 24, the ZBA recommended approval

of the Amendments per the attached "Exhibit A".

- The Planning, Building and Zoning Committee approved a resolution recommending adoption of the proposed amendments pursuant to conducted a final review of the proposed text amendments on September 29; the Committee's recommended modifications to "Exhibit A" are attached herewith as "Exhibit B".
- On October 6, 2009 the PB&Z Committee approved a resolution recommending adoption of the proposed amendments.

Joint resolution authorizing an emergency appropriation in the amount of \$7,000 in the Stormwater Management Commission budget (Fund 212) with offsetting increase in the revenue budget of \$7,000 to be reimbursed by the Illinois Environmental Protection Agency for conducting two winter maintenance workshops.

- Sodium chloride and other de-icing materials used for winter maintenance of streets, parking lots, and sidewalks contribute to water quality impairment of our lakes, streams, and rivers in Lake County.
- SMC along with the American Public Works Association, Lake County Division of Transportation, and the Lake County Health Department is sponsoring two (2) training workshops for applicators on better practices for snow and ice removal.
- These practices can significantly reduce the amount of de-icing material used during the winter season which will result in improved water quality.
- Illinois EPA will provide up to \$7,000 for the training consultant and material expenses incurred for the workshops.

Joint resolution authorizing an emergency appropriation in the amount of \$11,119 for a

total project account amount of \$2,109,353 in the Stormwater Management Commission budget (Fund 212) to be reimbursed by the Illinois Emergency Management Agency for the acquisition and demolition of eleven (11) floodprone properties throughout Lake County.

- This grant provides up to 75% cost-share funding for the purchase of eleven (11) floodprone properties throughout the County from owners that have voluntarily participated.
- SMC has entered into an agreement with the Illinois Emergency Management Agency (IEMA) to manage the acquisition and demolition of the eleven (11) properties.
- SMC will be reimbursed by the Illinois Emergency Management Agency from this grant award for grant management and technical services.

Ordinance Prohibiting Video Gaming within the unincorporated area of Lake County.

- Public Act 96-34, Public Act 96-37, and Public Act 96-38 were approved on July 13, 2009 and comprise the provisions of the Video Gaming Act.
- The Act allows video gaming in licensed bars, restaurants, fraternal organizations and truck stops throughout the state.
- The Act provides that the Illinois Gaming Board has jurisdiction over and will supervise all gaming operations. A local government is not responsible for administering or enforcing the provisions of the Act.
- The proceeds from video gaming are earmarked to pay for approximately 33% of the state's Major Capital Program. In addition, a local government will get 1/6th of the net tax from video terminals located within the local government's jurisdiction.
- The Act also provides that a local unit of government may prohibit video gaming within its jurisdiction. For the County, any prohibition would only apply to the unincorporated areas of the County. The County would then be responsible for enforcing this prohibition.
- The ordinance that is presented for consideration provides for the prohibition of video gaming in the unincorporated area of Lake County.

- The Illinois Criminal Justice Information Authority recently announced the availability of federal funding to support juvenile pre-employment programs at county juvenile probation departments.
- The Nineteenth Judicial Circuit was awarded \$39,852 in Juvenile Accountability Block Grant funds with a \$4,428 match from the Probation Services Fee Fund.
- The funding will be used to contract with local agencies and employers to provide approximately 30 youth with basic job and employment skills and paid internships.
- This resolution authorizes the execution of a program agreement, an emergency appropriation of \$44,280, and acceptance of the grant funding.

Joint resolution amending the Court Service Fee Ordinance to increase various fees imposed by the Ordinance and requesting concurrence of the Chief Judge of the 19th Judicial Circuit to impose the fee increases.

- The court services fee schedule, most recently adjusted in 2008, charges different rates for different types of cases.
- The current rates are between \$8 and \$20, all below the maximum fee of \$25 allowed by Illinois Statute.
- Given the current economic climate, it is deemed appropriate and necessary that the rates for all case types except small claims be increased to the statutory maximum of \$25. The fee for small claims cases will be increased to \$15.
- The Chief Judge will concur with this fee increase through an administrative order.
- The proposed fee structure will generate about \$934,000 in new revenue.

PUBLIC WORKS AND TRANSPORTATION COMMITTEE**51. 09-2045**

Ordinance authorizing a rate surcharge for certain portions of the combined waterworks and sewerage system of the County.

- A new code compliant water distribution system is being constructed in the Hawthorn Woods/Glennshire area and will be funded by revenue generated from the local area.
- The residents have been given an option on payment of their portion of the cost via either a one-time payment of \$11,600 or enrollment in a surcharge payment plan of approximately \$85.00 per month for 30 years (final amount determined at bond sale).
- This ordinance identifies the served parcels, the one-time capital cost amount, the surcharge payment amount, the parcels that have paid the one-time payment, and those parcels that will enroll in the surcharge payment plan.
- The last day to submit the one-time payment is October 2, 2009 after which all remaining parcels will be enrolled in the surcharge payment plan.
- The surcharge payment will begin in October, 2010 after the new system has been placed in service.

Ordinance Authorizing the Issuance and Sale of Water and Sewer System Second Lien Subordinate Revenue Bonds, Series 2009, and authorizing the execution of one or more bond orders in connection therewith.

- Subordinate Revenue Bonds (Series 2009) will be sold in order to finance the construction cost of the Hawthorn Woods Glennshire Water System.
- The final bond sale amount will be determined after October 2, 2009 when the total amount of direct payments from customers has been established. Per the bond ordinance, the bond sale is established at a not-to-exceed amount of \$4,000,000. However, based on our favorable bid prices, we are now projecting the bid sale at \$3.1 million.
- This ordinance will "Authorize the Issuance and Sale of Water and Sewer System Second Lien Subordinate Revenue Bonds, Series 2009, and authorizing the execution of one or more bond orders in connection therewith".

Joint resolution authorizing execution of a Wholesale Agreement for Sewage Disposal with the Village of Hawthorn Woods and authorizing the signing of the IEPA construction permit application for the Village's Special Service Area #4 interceptor sewer.

- The Village of Hawthorn Woods has established a Special Service Area #4 to serve certain parcels with sanitary sewer through the Village of Lake Zurich's local sewer system.
- In order to serve these parcels, the Village must execute a Wholesale Sewer Agreement with the County and must construct an interceptor sewer.
- One of the provisions contained in the Wholesale Agreement allows the County to serve the Taubman Property with sewer if it develops in unincorporated Lake County.

- The agreement limits the flow from the Village parcels to 3,000 PE, of which a maximum of 1,500 PE may be developed as residential.
- The Resolution authorizes the County Chair and County Clerk to execute the agreement and authorizes the Public Works Director to sign the IEPA Permit Application for the Village's interceptor sewer.
