#### 6.1 23-0117

Presentation and Discussion - Proposed Eighth Amendment to the Department of Housing & Urban Development (HUD) Program Year 2019 (PY19) Annual Action Plan (AAP). Dominic Strezo, Senior Grant Manager, presented the proposed action plan amendment. The main driver of this amendment is the upcoming spending deadline June 5, 2024 for the CARES Act funding received in 2020. This amendment shifts \$427,000 of funding from the PADS fixed shelter and a small portion of Prairie State Legal Services to existing Catholic Charities rental assistance and PADS emergency shelter – hotels grants.

#### 6.2 23-0116

Presentation and Discussion - Proposed Second Amendment to Program Year 2022 (PY22) Department of Housing & Urban Development (HUD) Annual Action Plan (AAP). Dominic Strezo presented the proposed action plan amendment. This amendment reallocates \$20,000 of the CDBG program administration to Lake County Partners to support a housing study and allocates \$185,000 of CDBG program income to Community Partners for Affordable Partners to support the acquisition and rental of a single family home. The amendment also includes a scope change for the Village of Round Lake Beach from a sidewalk to a parking lot.

Joint resolution approving the Eighth Amendment to the Department of Housing & Urban Development (HUD) Program Year 2019 (PY19) Annual Action Plan (AAP).

- HUD requires the submission of an Annual Action Plan (AAP) and associated amendments to govern expenditure of federal housing and community development funding for each program year.
- Community Development Block Grant Coronavirus relief funds (CDBG-CV) and Emergency Solutions Grant Coronavirus relief funds (ESG-CV) activities are included in the PY19 AAP regardless of the program year the activities are initiated.
- The proposed amendment includes the following changes:
  - Reduction in funding in the amount of \$416,485 for acquisition of a fixed site shelter (PADS Lake County).
  - Reduction in funding in the amount of \$10,515 for legal services (Prairie State Legal Services).
  - Allocation of \$227,000 for rental assistance program delivery (Catholic Charities).
  - Allocation of \$200,000 for hotel shelter costs (PADS Lake County).

#### 6.5 23-0142

Joint resolution approving the Second Amendment to Program Year 2022 (PY22) HUD Annual Action Plan (AAP) and authorizing an emergency appropriation in the amount of \$185,000.

- HUD requires the submission of an Annual Action Plan (AAP) and associated amendments to govern expenditure of federal housing and community development funding for each program year.
- The second amendment to the PY22 AAP makes the following changes:
  - Change in scope for \$100,000 of CDBG funds awarded to the Village of Round Lake Beach from a sidewalk extension project to parking accessibility improvements within the Village.
  - Reallocation of \$20,000 of CDBG program administration funds to Lake County Partners to support a housing study.
  - Allocation of \$185,000 of CDBG program income to Community Partners for Affordable Housing (CPAH) to support the acquisition and rental of a single-family home.

Brenda O'Connell, Community Development Administrator, lead a discussion on Commission feedback about Commission culture, meeting content and structural changes.

She explained the annual CDBG spending and timeliness test at the end of February.

Brenda presented a update on the progress of the off-cycle special application round projects using CBDG dollars to acquire single-family properties being sold by Lake County Housing Authority. The goal was to preserve the property as affordable housing and preserve residency of the current tenant.

She commented on the upcoming Point-in-Time Count that is scheduled for January 25th.

Finally, she walked through the current program year 2023 funding allocation process and highlighted what has been done and the upcoming ARC meetings to discuss the funding

recommendations to be presented to the full Commission and eventually the County Board for approval.
