Update and discussion regarding the State of Illinois 2025 Legislative Sessions.

Mike Grady, Strategic Advocacy Group, provided a summary of the State of Illinois 2025 legislative session thus far. Topics included bills related to: clean energy, civil rights violations related to immigration enforcement, mass transit, and the decoupling of Illinois corporate taxes from federal corporate taxes.

Derek Blaida, Strategic Advocacy Group, provided additional detail about the mass transit bill and pensions. Discussion ensued.

Matt Meyers, Deputy County Administrator, and Carissa Casbon, County Board Member, provided additional information regarding SB 2053 and HB 3100. Discussion ensued.
