My dad grew up in Scotland, one of 11, and emigrated to the US, following my mom. He was a skilled carpenter and came to America with \$35 and his toolbox. He could fix anything, and do anything, but he excelled most in making people feel welcome and loved.

He had a tremendous love of the outdoors – and was one of those rare people who had a way with animals and children. We lived in the woods, and even wild animals – birds, deer, rabbits, would come to him. He was always showing us the miracle of nature, things both big and small – from moss on the trees to the sky on a frigid winter morning.

As a true Scotsman, he loved all things Scottish and still had a strong brogue. My parents often threw large parties where someone would break out the bagpipes. But he especially loved golf and soccer, and shockingly supported both the Rangers (first) and the Celtics second, and my sisters and I spent many mornings and afternoons watching both with him.

He would have been 89 this past Sunday, and he and my mom would've been married 60 years in April. I feel very lucky to have had him as my father and

Coronavirus (COVID-19) Updates

As of March 7, 2023, Lake County has had over 176,809 confirmed COVID-19 cases and 1,528 deaths throughout the pandemic. Lake County's recovery rate is 99.2%.

Lake County remains at a "low" community level along with most counties in Illinois.

When a county is at a "low" community level, the CDC recommends:

Wearing a mask if you have symptoms, test positive, or have been exposed to someone with COVID-19 and when on public transportation.

Staying up to date with COVID-19 vaccines.

Getting tested if you have symptoms.

Talking to your healthcare provider if you are at higher risk of severe illness and in need of taking additional precautions.

Coronavirus (COVID-19) Vaccine Updates

The bivalent COVID-19 booster continues to be available throughout Lake County and is

recommended for everyone ages 5 and up who are fully vaccinated.

As of March 1, 2023:

Over 269 million people, or 81% of the US population, have received at least one dose of a COVID-19 vaccine.

Over 230 million people, or 69.3% of the US population, are fully vaccinated.

Over 53 million people, or 16.2% of the US population, have received the updated bivalent booster dose.

Nearly 87.6 % of all eligible Lake County residents, ages 5 years and older are fully vaccinated.

Recent Reported Increase in Opioid Overdose Events

The Lake County Health Department has recently reported an increase in opioid overdose events.

Between February 24 and March 1, 2023, there were 14 opioid overdose emergency department visits in six days among Lake County residents.

Preliminary data does not suggest a connection between events.

The Lake County Health Department is combating the opioid crisis in a multitude of ways, including the distribution of free Naloxone to community members and law enforcement personnel.

The Health Department reminds residents to be aware of the symptoms of an opioid overdose and how to administer Naloxone.

Residents can visit www.lakecountyil.gov/naloxone to learn more and order naloxone today.

National Groundwater Awareness Week

In Observance of National Groundwater Awareness Week, the Lake County Health Department is offering a reduced well water testing fee for homeowners who use well water as their primary source of drinking water.

Between March 6 and March 17, 2023, the normal \$18.00 fee for testing for bacteria and nitrates will be reduced to \$15.00.

Sterile test bottles and sampling instructions are available at the Lake County Central Permit Facility at 500 W. Winchester Road, Libertyville, the Health Department's headquarters at 3010 Grand Avenue, Waukegan, and 19 township or municipal offices located throughout Lake County.

An estimated 145 million Americans get their tap water from a groundwater source. While most of the time, U.S. groundwater is safe to use, testing groundwater can help ensure that it has not become contaminated with germs and chemicals that could make people sick.

World TB Day

On March 24 each year, we recognize World TB Day. This annual event commemorates the date in 1882 when Dr. Robert Koch announced his discovery of *Mycobacterium*

tuberculosis, the bacillus that causes tuberculosis (TB).

Many people still suffer from TB. If left untreated, 1 in 10 people with latent TB will get sick with active TB, which can spread to others and be deadly.

The Health Department's Tuberculosis Clinic provides screening, testing, consultation, education, treatment, and home visits for anyone living, attending school, or working in Lake County.
