Mr. Rigg's work experience is below.

Director of Public Works Oct. 2017 - July 2024 City of Burlington, WI

- Responsible for all operational functions of the Department of Public Works.
- Supervise, lead, and develop the 23 full-time staff of the Department.
- Solicit, hire, and manage professional services contractors for projects and ongoing services including
 design engineering, construction management, and regulatory compliance.
- Research, prepare, and present funding requests and policy recommendations to the Common Council for consideration.
- Develop and implement annual operating budgets for the Department including revenue projections for water and wastewater utilities. Coordinate rate studies and implement rate adjustments for the utilities.
- Develop and implement long range capital plans for maintenance of public infrastructure, utilities, public buildings, fleet and other asset replacements.
- Secure grant funding for capital projects.
- Collaborate with other government agencies, regulators, non-profits, and private business on development projects and impactful public improvements.

Assistant to the Director of Public Works/Operations Manager Aug. 2013 - Oct. 2017 Village of Grayslake

- Managed daily operations of the Public Works Department.
- Daily supervision and scheduling for full time union staff (4) and seasonal staff.
- Tracked and analyzed all production to achieve productivity goals.
- Oversight and management of service contracts.
- Assisted with development of annual budgets and ensured operations were accomplished within budgetary parameters.

Assistant Operations Director Feb. 2009 - Aug. 2013 City of Janesville, WI
