GED/HSE

- The Regional Office of Education assists individuals who are seeking to earn their GED or High School Equivalency Certificate.
- The Regional Office of Education also maintains and issues GED and High School Equivalency Certificates.



Bus Driver Trainings

- There are over 1,500 school bus drivers in Lake County servicing public and non-public schools.
- Experienced drivers must take a 2-hour refresher course annually, while all new drivers must take an 8-hour course in school bus driver safety and first aid, prescribed by the Illinois State Board of Education, and administered by the Regional Office of Education.
- The Regional Office of Education is responsible for the appointment of instructors who conduct the required training.
- The Secretary of State's Office is responsible for the issuance of school bus driver permits, and the administration of behind-

the-wheel testing.

The Attendance and Truancy Division is Lake County's truancy and dropout prevention program funded by the Illinois State Board of Education (ISBE) since 1985 and administered by the Lake County Regional Office of Education.

Homelessness/Pre School

- The ROE provides support for the 67 school district liaisons and their districts in Lake and McHenry Counties in administering the McKinney-Vento Homeless Children Act federal Law.
- About 2000 students are identified each year in the two counties with Lake County accounting for 2/3 of the total.
- We assist the identified children by providing school supplies and eliminating any barriers that may prevent the McKinney-Vento students from becoming successful students.

- The Coalition represents 584 childcare and preschool programs in Lake County, both private and school based.
- For the past ten years Matt Tabar and Jim Menzer have been members the Coalition, representing the Regional Office of Education, serving as Treasurer and Advocacy Chair respectively.

Regional Safe School Program



The Regional Safe School Program of Lake

County serves students in grades 6 – 12 who

have received multiple suspensions, are eligible

for expulsion, or have been expelled from a

local school district in Lake County, Illinois.

B.A.S.E. Program

The Behavior, Academic, Social, and Emotional (B.A.S.E.) Program is our alternative to long-term student suspension program.

The B.A.S.E program is a suspension intervention program, which provides short-term services to middle and high school students across Lake County in lieu of out-of-school suspension. Students who attend the program will work alongside licensed teachers to complete coursework as well as participate in reflective conversations regarding behavior. Upon completing the program, transition meetings are held with students, families, members of the B.A.S.E. Program, and district staff to review the placement, identify concerns regarding re-entry, and plan for support services if needed.

Regional School Board of Trustees

- The Lake County Regional Board of School Trustees is an elected board comprised of seven members.
- This elected board hears petitions for annexations, detachments, and changes in school district boundaries.
- The Regional Superintendent acts as the Ex-Officio Secretary to the Board.
- The Regional Office maintains all records of petitions filed in the region.
- There has not been a hearing since 2018

We are committed to creating a culture of well-being of students, staff, parents, and community. In an effort to continuously support this commitment, the Lake County Regional Office of Education has entered an agreement with ReferralGPS.

ReferralGPS is a web-based service focused on assisting our students, staff, and community in finding local mental-health and substance use related treatment. The service compliments the districts existing systems of support as a tool for student service teams and families to connect with treatment. Along with a searchable database of treatment options, ReferralGPS provides Care Navigation to assist families in triage, appointment setting, and follow up care.

School families may access ReferralGPS in two ways:

- Contact Student Services for the Lake County school the child attends (social workers, psychologists, counselors) to seek out treatment options.
- Visit this link at https://referralgps.com/find-help/LAKE to search for treatment resources or connect with a Care Navigator anonymously.

ReferralGPS takes into account all types of private and public insurance including PPO, HMO, Medicaid, Medicare, and families who are uninsured or underinsured. The platform also filters by age, gender, zip code, and special requests.

ReferralGPS is available for use by district students, staff, and families at no cost. All information entered on the ReferralGPS tool is completely confidential and securely stored.


