Dear Chairman Carlson:

On behalf of the Village of Barrington, I am responding to the request for additional information which the Lake County Health and Community Services Committee and staff requested at the meeting on May 25, 2010 regarding our application for the 2010 Lake County Brownfield Grant. We hope this additional information will answer your questions and have a positive impact on our request for funding.

**TIF Funds Allocated for Remediation:**

The property is located in the Village Center Tax Increment Financing District. The Village will use funds in the TIF allocation fund to provide to pay for its share of the remediation to the building located at 322 North Hough Street. The budget has \$100,000.00 allocated for remediation projects within the TIF district. At this time a portion of the funds would be allocated to this project. Additionally, no other remediation projects are set to begin within the next six (6) months. However, in 2011 the Village will undertake remediation efforts on the Hough Main Redevelopment project area which is in Cook County, but it will not have an impact on this project.

**Updated Cost Breakdown:**

The Village has consulted with Aries Consulting, Inc. to confirm the environmental remediation budget for this project in 2010 dollars. Attached is a letter from Aries Consulting verifying the cost and project oversight. The chart below reflect the Village's request for grant funding to include the consulting cost for the project management.

**Project Timeline:**

The Village of Barrington is actively seeking a tenant and or redevelopment partner to occupy the property located at 322 North Hough Street, Barrington, IL. This request for funding was made at this time because there is an interested prospective business that would move quickly to renovate and move into the building. The Committee requested about our commitment to move forward with the remediation project if such a tenant is not secured and at what date this work would commence. Based on the Environment Phase I report, there are only certain elements which will need to be remediated immediately and others would be pursued when disturbed, i.e. when the building is gutted and renovated. However if a tenant is not secured within six (6) months (November 1, 2010) then the Village would proceed to clean up the property as an incentive to lure a tenant to the space. Following are two scenario timelines relative to work being completed if grant funds were secured.

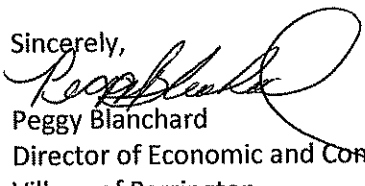

Per your recent request, Aires Consulting Group, Incorporated is submitting the following budgetary pricing for asbestos abatement activities at the noted facility.

Aires pricing is based on reviewing an asbestos building inspection report of the noted facility, prepared by JR Associates, Inc. of St. Charles, Illinois and conducted on December 1, 2000. Please note that Aires has not inspected the noted facility and the written report is the sole basis of our estimates. We make no warranty of the current presence and condition of the materials in the building.

The attached information discusses potential asbestos abatement costs for this facility.

**Note:** Since Aires has not seen the facility, we cannot give an opinion on the condition of the asbestos materials. Removal of asbestos materials is required when they become friable and have the potential to become airborne, creating a potential health issue for building occupants. Otherwise, if in good condition, materials can be left in place and managed.

Costs for the asbestos abatement removal of all the materials is also included. These costs are based on the estimated quantities of both confirmed and assumed materials. Costs are for asbestos abatement contractor only. Additional environmental consulting fees may be applicable for project management, specification development of air monitoring.

### **Budgetary Asbestos Project Consulting Costs**

Guideline/Specification Development \$1,200.00

Includes: Creating Guideline/Specifications for abatement of all materials noted above and a single walk-thru with contractors for abatement pricing.

Project Management/Air Sampling (PM/ASP) \$800/8-hour shift

Includes: Providing all asbestos project management and air sampling for the abatement project to insure contractor is performing the project according to the specifications and maintaining regulatory compliance.

Estimated total shifts to complete all items noted above, except for the roofing materials, is nine (9) shifts.

10 x 800/shift= \$8,000.00

Total asbestos consulting costs: \$9,200.00  
(excluding roof removal)
