Dear Mr. Sauer,

I am writing to express my interest in being reappointed to the Wauconda Fire Protection District Board of Directors at the conclusion of my current two-year term, which expires on April 30, 2013. This is my first term. Prior to being appointed, I worked closely with the leadership of the Village of Wauconda, Wauconda Fire Protection District, and Wauconda Police Department in leading a citizen's committee to champion a referendum to bring Wauconda into the Fire Protection District. Since being appointed, I have missed one meeting due to personal travel. I was appointed by Board President Bilisko to assume the role of Secretary upon the unfortunate and unexpected death of my predecessor. In addition, I have represented the Board and President Bilisko at a quarterly meeting of the Mayoral Roundtable for Elected and Appointed Officials, including hosting and organizing that meeting on one occasion.

As indication of my sincerity in understanding the position, I have completed required, on-line training provided by the office of the Attorney General (FOIA and OMA). In addition, I completed the three-part training for Fire Protection District Trustees provided by the Illinois Association of Fire Protection Districts. Most recently, I completed an additional four hours of live trustee training provided by the Northern Illinois Alliance of Fire Protection Districts. These live, interactive training sessions present me with a significant number of contacts in other Fire Protection Districts in addition to the expertise of the faculty panels.
