Dear Mr. Buehler

Representatives from the Lake County Sheriff's Emergency Dispatch Department, Countryside Fire District, U.S. Post Offices and the Lake County GIS/Mapping Division attended the Sylvan Lake homeowner's annual meeting and discussed the importance of the community complying with Lake County's five-digit addressing system and using the correct platted street names. The Sylvan lake area is using a non-compliant addressing system that does not flow in a constant logical pattern; this presents obstacles for police, fire and paramedic services. Additionally, street names are confusing. Fremont Township Highway Department recommends and approves the address and road name changes being proposed for the Sylvan Lake Subdivision. The roads being renamed are:

- Sylvan Drive West and North to Sylvan Drive
- Crescent Drive North, East and South to Crescent Drive

We are working with the homeowners and Lake County Mapping department to make the transition as smoothly and trouble-free as possible. If you need additional information regarding this change, please do not hesitate to contact me.

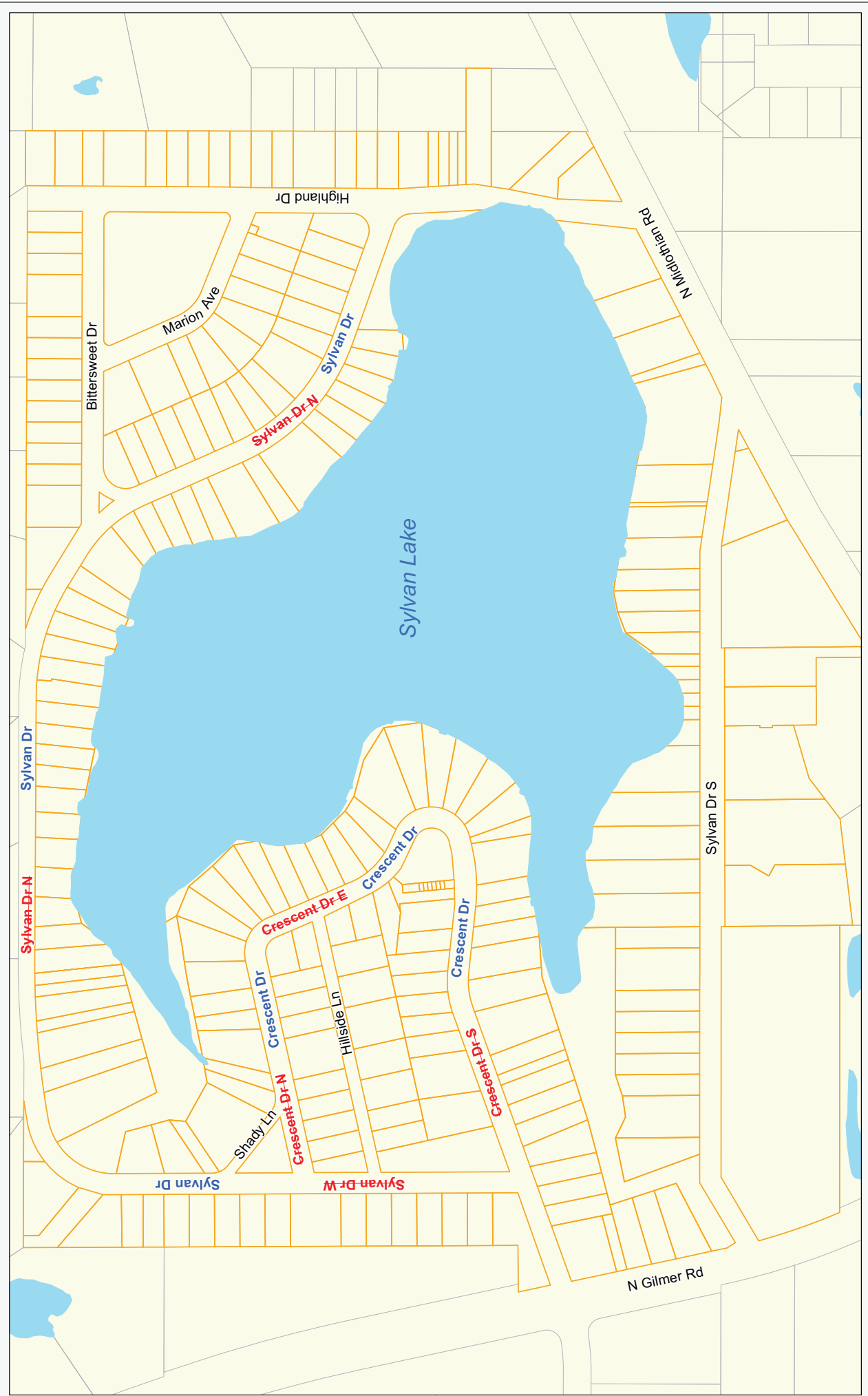
