## 12. Lake County Community Health Center Governing Council Update

Kim Burke, Director of Healthcare Operations, informed the Board that the Governing Council last met on April 9, 2024, and in addition to the standard agenda items, they approved 3 action items and reviewed 1 discussion item.

Mark Pfister added that the Health Center Annual Needs Assessment looks very closely at where clients are coming from. At LCHD's North Shore Health Center in Highland Park nearby zip codes account for only 4% of LCHD's total client population so that location has open appointment slots resulting in clients having to drive there from Waukegan, Zion, and North Chicago. It is also not in the location it was originally intended to be and the area has now grown residentially and commercially with a large condominium complex and multiple retailers posing traffic and parking issues. Since the North Shore Health Center may not be meeting the needs of LCHD clients, Mark and Kim are going to be reviewing with the Governing Council whether it is a site that LCHD needs to divest or use for other purposes.
