Preliminary discussion on FY2026 New Program Requests (NPR)

Mr. Woolford began the discussion on the FY2026 New Program Request (NPR) Process, which includes reporting on performance measures for prior NPRs received in FY24/FY25. Mr. Woolford handed out a list of the NPRs that SMC received in FY24 and provided the following updates: 1) Comprehensive Stormwater Management Plan Update – ongoing; 2) Part-time Wetland Specialist position – filled; 3) Stream and Channel Maintenance pilot program – ongoing; 4) Lake Michigan PCB Mercury TMDL Compliance Testing – ongoing; 5) Staff Augmentation for Outfall and Facility Inspections – on hold. Mr. Woolford also handed out a list of projects for the Maintenance Pilot Program. Commissioner Maine asked if SMC received or would be requesting \$60,000 for the Stream and Channel Maintenance pilot program. Mr. Woolford clarified that SMC received \$60,000 for the pilot program in FY24, and the continuation of annual funds is recommended to be offset from SMC's SIRF program. Commissioner Maine inquired on the duration of the pilot program and Mr. Woolford responded that the Maintenance Pilot Program would be terminated upon adoption of the Comprehensive Stormwater Management Plan update.

Commissioner Hewitt asked about the McArthur Drive SIRF project. Mr. Frank provided an update and noted that the City of Waukegan are working on it after SMC provided assistance. Mr. Woolford added that SMC would be working with LCDOT on the York House Road improvements to make sure the storm sewer system has enough capacity for the offsite flow from the Village of Beach Park and also from the area where McArthur

Drive is. Commissioner Hewitt and Mr. Woolford agreed that a meeting with the City of Waukegan is the preferred next step.

Mr. Woolford began the discussion on FY26 NPRs and the process. After some discussion, and in consideration of the current workload capacity, the Commission's direction was to not submit any NPRs for FY26.
