Derek Blaida, Strategic Advocacy Group, provided a summary of the State of Illinois 2025 legislative session thus far. Topics included: Veto Session, Governor's Executive Order pertaining to a budget holdback, and the Mass Transit Bill. Discussion ensued.

8.3 <u>25-1319</u>

Update and discussion regarding Federal Legislative items.

Greg Bales, McGuire-Woods Consulting, LLC, provided a summary of the Federal 2025 legislative session thus far. Topics included: the Federal government shutdown, Federal Budget, Extension of Affordable Care Act tax extensions, and Federal grants. Discussion ensued.

Discussion regarding the draft 2026 Legislative Program and additional concepts.

Matt Meyers, Deputy County Administrator, provided an overview of the Draft 2026 Legislative Program. Discussion ensued.

Deputy County Administrator Meyers invited staff to speak regarding additional initiatives to potentially add to the Draft 2026 Legislative Program.

Walter Willis, Solid Waste Agency of Lake County (SWALCO), provided an overview of the SWALCO Legislative Program for potential inclusion in the Draft 2026 Legislative Program. Topics included food scrap diversion, household hazardous waste recycling, mattress disposal, and plastic and paper bag fees. Discussion ensued. The consensus of the majority of the Committee was to add these initiatives as topics of interest to the Draft 2026 Legislative Program.

Sandy Hart, County Board Chair, provided an overview of the current licensing restrictions for engineers based on Illinois State statute. The consensus of the majority of the Committee was to have staff research the topic further.

Chair Wasik provided an overview of legislation that would restore financial support to those who monitor bodies of water. The consensus of the Committee was to add this initiative to the Draft 2026 Legislative Program.

Deputy County Administrator Meyers provided an overview of the bills listed below for the Committee to consider supporting:

HB 4086 and the No Secret Police Act of 2025: Derek Blaida, Strategic Advocacy Group, provided background regarding HB 4086. Discussion ensued. Chair Wasik requested a roll call consensus for this item. The following Members were in support of HB 4086 and the No Secret Police Act of 2025: Vice Chair Campos, Member Roberts, Member Vealitzek, and Chair Wasik. The following Members were not in support: Member Hunter and Member Schlick. Member Kyle was absent. Therefore, the consensus of the majority of the Committee was to support HB 4086 and the No Secret Police Act of 2025.

SB 2053 and HB 3100: Carissa Casbon, County Board Member, provided background regarding SB 2053 and HB 3100, which would change grant matching requirements for convention and tourism bureaus and alter how funds are distributed. Discussion ensued. The consensus of the majority of the Committee was for staff to research the topic further.

Member Schlick left the meeting at 2:36 p.m.

HB 4141: Member Vealitzek and Eric Waggoner, Planning, Building and Development Director, provided background regarding HB 4141, which would prevent counties and municipalities from prohibiting non-commercial solar energy systems. Discussion ensued. The consensus of the majority of the Committee was to support HB 4141.

Member Hunter left the meeting at 2:57 p.m.

HB 1370 (Microfiber Act): Robin Grooms, Sustainability Programs Manager, provided background regarding HB 1370, which would require all new washing machines after the year 2030 to have a microfiber filter. The consensus of the majority of the Committee was to support HB 1370.

SB 2196 (Powering Up Illinois Act): Robin Grooms, Sustainability Programs Manager, provided background regarding SB 2196, which would require electric utilities serving over 200,000 customers to upgrade electrical distribution systems. The consensus of the majority of the Committee was to support SB 2196.

Chair Wasik requested that legislation pertaining to the Route 53 Greenway be added to the Draft 2026 Legislative Program as an item of interest.
