Joint resolution approving an intergovernmental agreement (IGA) for contractual police services by and among the Villages of Lake Barrington and North Barrington, Lake County and the Lake County Sheriff's Office (LCSO) from January 1, 2026, to December 31, 2028, in the estimated annual amount of \$1,156,970.89.

- The Villages of Lake Barrington and North Barrington have agreed to renew the police services contract for a three-year period from January 1, 2026, to December 31, 2028, in the estimated annual amount of \$1,156,970.89 with a 3 percent cost of living adjustment for personnel costs for years two and three.
- Based on previous calls for service, the Village of Lake Barrington pays 68 percent of the total monthly cost, and the Village of North Barrington pays 32 percent of the total monthly cost.
- The contract continues the 24-hour one car per shift services, seven days per week, every day of the year.

- This renewal contract maintains three deputies per day working eight and one-half (8.5) personnel hours per shift which allow for overlap of services to facilitate shift changes.
- The State's Attorney's Office, County Finance and the Risk Department have reviewed this renewal contract.
- The Villages of Lake Barrington and North Barrington will reimburse the cost of the three contract deputy positions for all three years.

Joint resolution approving an intergovernmental agreement (IGA) for contractual police services by and among the Village of Beach Park (Beach Park), Lake County and the Lake County Sheriff's Office (LCSO) from January 1, 2026, to December 31, 2028, in the estimated annual amount of \$771,313.93.

- Beach Park and LCSO have agreed to renew the police services contract for a three-year period from January 1, 2026, through December 31, 2028 in the estimated annual amount of \$771,313.93 with a 3 percent cost of living adjustment for personnel costs for years two and three.
- LCSO has provided police services to Beach Park for 24 years.
- The contract includes a continuation of the current services which include two 8.5-hour shifts per day, from 6:30 a.m. to 11:00 p.m.
- The State's Attorney's Office, County Finance and Risk Department have reviewed this renewal contract.
- Beach Park will reimburse the cost of the two contract deputy positions for all three years.

Joint resolution authorizing the acceptance of a state fiscal year (SFY) 2026 Juvenile Justice Council (JJC) grant awarded to the Lake County State's Attorney's Office by the Illinois Juvenile Justice Commission (IJJC) through the Illinois Department of Human Services (DHS) to enhance and strengthen the Lake County JJC, which is run by the Lake County State's Attorney's Office, and approving an emergency appropriation of \$80,000 in grant funds.

- The Lake County Juvenile Justice Council (JJC) is a collaborative effort of many government and private agencies addressing juvenile justice procedures and programs that are proactive in preventing delinquency.
- The Lake County State's Attorney's Office has been awarded a seven-month JJC Grant, December 1, 2025, through June 30, 2026, in the amount of \$80,000 from the Illinois Juvenile Justice Commission (IJJC) through the Illinois Department of Human Services (IDHS).

- Grant program funding in the amount of \$80,000 will support the creation and purchase of preventative/proactive printed materials and giveaways, webpage/website designer, attendance at the annual Juvenile Justice Council Conference, and two part-time, contracted positions - a JJC Coordinator and a Racial and Ethnic Disparity Reduction Coordinator.
- The source of funding for this JJC project is 100 percent grant funds; no matching funding is required.
- If funding for the positions and services end, and new funding is not secured, the positions and services will be eliminated.

Joint resolution authorizing the acceptance and execution of a Bloodsworth grant awarded by the Bureau of Justice Assistance (BJA) to the Illinois Innocence Project (IIP) of which the Lake County State's Attorney's Office (LCSAO) is subgrantee, to partner with the LCSAO to reduce the number of wrongful convictions within Lake County including an emergency appropriation of \$245,327 in grant funds.

- The Lake County State's Attorney's Office (LCSAO) has been awarded a Bloodsworth grant of \$245,327 through the Bureau of Justice Assistance (BJA) as subgrantee through the Illinois Innocence Project (IIP).
- The proposed one-year grant term is October 1, 2025, through September 30, 2026.
- The Illinois Innocence Project (IIP), who will act as lead agency, seeks to collaborate with the Lake County State's Attorney's Office (LCSAO) as subgrantee, to support DNA casework and reduce the number of wrongful convictions, including litigating postconviction cases.
- LCSAO will use funds for the salary and fringe of a part-time (.5 FTE) Conviction Integrity Unit Director (position 41185), along with both a contracted paralegal and investigator, expert witness testimony and computer software.
- If funding for the positions and services end, and new funding is not secured, the positions and services will be eliminated.

Joint resolution authorizing an emergency appropriation in Fund 254 Children's Waiting Room to fund benefits expenses of the Fiscal Year 2025 budget in the amount of \$8,200 from the Fund 254 fund balance.

- Lake County has incurred expenses benefits that exceed the amount approved in the Fiscal Year (FY) 2025 budget due to a change in benefit elections that occurred after the FY 2025 budget was finalized.
- There are sufficient reserves in the fund to cover this emergency appropriation and should this additional appropriation not be fully utilized, it will fall back into the Children's Waiting Room fund balance at the end of FY 2025.

- The current fund balance is approximately \$430,000, so there are sufficient funds to cover this unbudgeted expense.

- This resolution would endorse the 2026 solar group buy program organized by the Midwest Renewable Energy Association and the Citizens Utility Board which encourages and provides discounts for solar panel installations through Lake County promotion and participation in the initiative.

- The Salem Group has been providing temporary employee services for Lake County since 2006.
- The Lake County Board approved a resolution on January 12, 2021, authorizing Lake County to utilize the Lake County Health Department contract for temporary employee services.
- There is a need to extend the current agreement with The Salem Group through March 31, 2026, in order to continue service and provide time to secure a new contract.
- The Purchasing Agent has determined that an emergency procurement exists to prevent serious disruption of government services.
- This change is germane to the original contract as signed and is in the best interests of the County.
- This contract extension will cost the County an estimated amount of \$450,000.

Resolution to enter into a contract with Nutrire Vending, LLC, Hillside, Illinois, for food and vending services for Lake County for a two-year period plus three one year renewals.

- The current contract for food and vending services will expire on February 7,

2026.

- There is a need to enter into a new contract for food and vending services.
- A request for proposal (RFP) was sent to 281 vendors and proposals were received from two vendors.
- An interdepartmental committee comprised of representatives from the Nineteenth Judicial Circuit Court, Facilities and Construction Services, County Administration, and Finance and Administrative Services reviewed the proposals and interviewed the two firms.
- Based on the criteria set forth in the RFP, the evaluation group selected Nutrire Vending, LLC, as the most favorable proposal for Lake County.
- Lake County will receive commission based on a tiered commission structure: Year One - 15%, Year Two - 17.5%, Year Three - 20%.
- Based on sales and revenue Lake County may be required to subsidize the Coffee Kiosk.

Tax Abatement Ordinance for the Series 2022 General Obligation Refunding Bonds.

- The County issued these bonds as alternative revenue bonds, meaning the taxes are paid from revenue other than property taxes.
- If the County has insufficient alternative revenue, it must pay for the debt service with tax levy funds. For that reason, there is a tax levy in the County Clerk's records for payment of principal and interest on these bonds.
- Each year, the County must determine that it has sufficient funds to pay for the debt service and file an ordinance with the County Clerk for tax abatement stating that there is no need for a tax levy to pay debt service.

Tax Abatement Ordinance for Special Service Area Number (SSA #) 16 tax levy.

- SSAs are created to allow improvements to be made and debt to be issued to pay for these improvements. The debt service is then paid for by a special tax levy.
- Each year, a separate tax is levied on the properties within the designated area to pay the debt service issued to pay for the improvements.
- This SSA provides funds for the repayment of bonds issued for construction of water supply improvements and extensions to provide access to Lake Michigan Water through the existing system of the Central Lake County Joint Action Water Agency (CLCJAWA).

Resolution authorizing an emergency appropriation in the amount of \$32,000 for services in Special Service Area Number 17 (SSA #17), Ivanhoe Estates.

- Special Service Area #17 was established to fund the repair, reconstruction and maintenance of private streets within the Ivanhoe Estates residential community.
- The amount budgeted in the fiscal year (FY) 2025 budget was \$14,160 for expenses, an amount equal to the levied property tax revenue for FY2025. However, repairs approved by the residential community require additional funding in the amount of \$32,000.

- A fund balance exists in an amount of \$71,628 at the end of FY2024 and \$13,822 in property tax revenue has been received year to date with no expenses. Therefore, there are sufficient funds for the road repairs.
- This resolution appropriates funds in Fund 290 SSA #17 for payment of FY 2025 contractual services for the additional amount of \$55,000.

Resolution authorizing emergency appropriations for Fiscal Year (FY) 2026 in various funds for certain projects, items, and activities budgeted in the prior year and not completed.

- Since all unused appropriations lapse at the end of each fiscal year, it is necessary to “carry over” unspent budget authority from one fiscal year to the next under certain conditions as defined in the County’s Budget Policies.
- These carryover requests include contracts which were unable to be completed in FY 2025 and uncompleted or ongoing projects that will not be complete until FY 2026.
- These items must be authorized through what is termed an “emergency appropriation” in order to transfer the budget authority that was previously granted in FY 2025 to FY 2026. The detailed accounts are included in the attachment.

- Line-item transfers in various funds between line-items in the FY 2025 budget are needed to align the budget with correct expense accounts.
- The County Board must approve line-item transfers under certain conditions.
- A listing of the various transfers is attached to the resolution.
- This action does not increase budget authority; it simply transfers previously approved budget authority.

Resolution authorizing an amendment to the Route 173 Corridor Intergovernmental Agreement between Old Mill Creek, Wadsworth and Lake County, establishing a termination date of January 31, 2026.

- The Route 173 Corridor Intergovernmental Agreement (“the Agreement”) was executed in 2006 between Old Mill Creek, Wadsworth and Lake County (“the parties”) for the purpose of establishing joint control over land use and development aesthetics and requiring sewer/water infrastructure services for all

new development within a defined geographical area surrounding the 173/94 interchange ("the Gateway Area").

- Since the adoption of the agreement, various Agreement restrictions, primarily the lack of available public sewer and water service, have prevented development within the Gateway Area.
- In 2025, the parties mutually agreed through a Memorandum of Understanding (MOU) to exempt a specific section of the Gateway Area from the strict terms of the Agreement in order to accommodate a development not otherwise permitted by the Agreement.
- In recognition of the continued challenges the Agreement's terms impose on potential development within the remainder of the Gateway Area, and to expeditiously facilitate additional potential development within its boundaries, the parties collectively agree to terminate the Agreement effective January 31, 2026, nine months prior to the Agreement's original expiration date of November 14, 2026.

- LCSAO will use these funds to cover 100 percent of the salary and benefits of the five Gun Violence Prevention Initiative (GVPI) staff, printed materials and other outreach supplies and a subaward to the Waukegan Township for the GVPI Peacemaker services.
- If funding for the positions and services end, and new funding is not secured, the positions and services will be eliminated.

Joint resolution authorizing the first amendment to the Amended and Restated Agreement for Retail Sanitary Sewer Service between Lake County and the Village of Hawthorn Woods.

- The County and the Village of Hawthorn Woods entered into an Amended and Restated Agreement for Retail Sanitary Sewer Service, dated April 8, 2025.
- The Village desires to amend the agreement to offer sanitary sewer service to a 56-acre property designated as “Kemper Ridge”, which will consist of residential development.
- The County’s extension of retail sanitary sewer service will ensure continued sanitary sewer collection, transportation, and treatment to the areas of the Village to be served under this agreement.
- The Village of Hawthorn Woods is scheduled to act on the amended agreement at the Village Board meeting on December 16, 2025.
- The County has determined that, subject to the agreed terms and conditions in the agreement and amendment, the new properties are feasible for the purpose of constructing the residential development.
- This resolution authorizes execution of the first amendment of the Amended and Restated Agreement between the County and the Village of Hawthorn Woods.
- In accordance with County Board Rules, the State’s Attorney’s Office has reviewed this first amendment to the Agreement prior to action by the County Board.

Joint resolution authorizing the execution of the first amendment to the Restated and Amended Agreement for Sewage Disposal between Lake County and the Village of Lake Villa (Village).

- The County and the Village entered into a Restated and Amended Agreement for Sewage Disposal, dated January 14, 2025.
- The County Board approved the *Transfer of Former Lakes Region Sanitary District Assets and Responsibility Policy* dated May 12, 2024, which outlined the process for transferring sanitary sewer assets and responsibilities, which the County assumed as a result of the dissolution of the former Lakes Region Sanitary District.
- The Village submitted a request to the County to transfer the ownership and operations of sanitary sewer assets within the Prairie Trails Subdivision and the Phase 1 and Phase 2 of Cedar Ridge Subdivision, all located within the Village boundaries.

- The request was reviewed and found to be in accordance with the policy by the Department of Public Works and the County Administrator's office.
- The transfer of sanitary sewer assets to the Village of Lake Villa would provide for the Village to own, maintain and manage the sanitary sewer collection system in these neighborhoods.
- The Village of Lake Villa approved the Amendment to the Agreement on October 20, 2025.
- This resolution authorizes the execution of the Amendment between the County and the Village of Lake Villa to allow for this transfer of assets and to reflect as such in the agreement service area.
- In accordance with County Board Rules, the State's Attorney's Office has reviewed this Intergovernmental Agreement prior to action by the County Board.

Joint resolution authorizing a contract with Copenhagen Construction, Inc., Union, Illinois, in the amount of \$4,421,079.17 for non-motorized improvements along Washington Street, from Sextant Drive to Almond Road, and appropriating \$5,305,000 of County Option Motor Fuel Tax funds.

- The improvements include installing a new bike path along the south side of Washington Street from Mainsail Drive to United States Route 45, and on the north side of Washington Street from United States Route 45 to Almond Road.
- The improvements also include installing new sidewalk along the north side of Washington Street from Sextant Drive to Mainsail Drive, and along the south side of Washington Street from Tangueray Drive to Almond Road.
- There was a public call for bids, and a total of seven bids were received, ranging from \$4,421,079.17 to \$5,359,516.20 and the lowest responsible bidder is Copenhagen Construction, Inc., Union, Illinois, in the amount of \$4,421,079.17.
- This project is included in the Transportation Improvement Program with construction to begin in 2026 and designated as Section 21-00110-15-BT.

Joint resolution authorizing a contract with Berger Contractors, Inc., Wauconda, Illinois, in the amount of \$2,867,174.87 for the intersection improvements of Deep Lake Road at Depot Street, and appropriating \$3,555,000 of County Option Motor Fuel Tax funds.

- The intersection improvements of Deep Lake Road at Depot Street will include the installation of a roundabout and non-motorized improvements.
- The project will require a 100-day closure at the intersection to construct the roundabout.
- The contract includes incentives to the contractor for opening the intersection early and disincentives if the closure goes beyond 100 days. Reducing the duration of the closure is a direct benefit to the public including motorists, residents, first responders, and area schools.
- There was a public call for bids, and a total of six bids were received, ranging from \$2,867,174.87 to \$3,559,584.56 and the lowest responsible bidder is Berger Contractors, Inc., Wauconda, Illinois, in the amount of \$2,867,174.87.
- This project is included in the Transportation Improvement Program with construction to begin in 2026 and designated as Section 19-00132-05-CH.

Resolution approving an intergovernmental agreement (IGA) to install a public Wi-Fi project and provide service through December 2026 by and between Lake County and the City of Waukegan.

- Lake County's Broadband and Digital Equity Action Plan has a goal to expand countywide access to reliable, high-speed broadband infrastructure by increasing free public Wi-Fi in areas within Lake County.
- Lake County will provide for the purchase, installation, service, and support of a public Wi-Fi project at specific locations, including Waukegan, identified within Lake County by the Broadband and Digital Equity Action Plan.
- The agreement between Lake County and the City of Waukegan will bring free internet to the community, allowing Waukegan residents to access online resources for their essential needs.
- Funded by Lake County, using American Rescue Plan Act (ARPA) funds, this agreement will end on December 31, 2026 in alignment with the expenditure deadline of the funds.
- The City of Waukegan has identified locations where the public Wi-Fi will be installed and service will be made available to its residents, who will benefit from being able to connect to the internet more affordably or with greater bandwidth than they may currently access. Once installed, the City of Waukegan will operate and maintain the Wi-Fi infrastructure according to the terms of the Agreement.
