Request for Position Reclassification

Action Requested:

Reclassify position number 46000 Job Center Supervisor, M6 to Job Center Manager, M8 to align with significant added responsibilities.

Analysis

The Job Center Supervisor position is currently graded an M6. The Job Center Supervisor has taken on added responsibilities including managing the Workforce Development Board Job Center Action Plan, identified as first line of communication for the Job Center partners (14 mandated partners), and on-site lead role for the One Stop Operator (One Stop Operator is the partnership of Workforce Development, IDES, College of Lake County and IL Department of Rehabilitation Services). Additionally, the Job Center Supervisor is responsible for customer flow and partner integration. The recommended reclassification to a grade M8, in conjunction with a 5% increase in base will assist in the retention of the incumbent.
