- I also had a conference call with HB2418 Senate sponsor Pam Althoff and House Sponsor David McSweeney.
- Senate Bill 2677 Testimony

While I was in Springfield, I appeared before the Senate Judiciary Committee to support SB2677 which seeks to give counties the same leverage as municipalities in settling liens that have been imposed due to public safety concerns (such as demolition of an unsafe structure) prior to title transfer. The bill passed out of committee unanimously.

- Council of Government Legislative Events

This month, I attended the Northwest Municipal Conference's legislative brunch, which brought together legislative and municipal leaders from Lake and suburban Cook Counties. I also attended the Lake County Municipal League and Barrington Area Council of Government's legislative breakfast. Both events raised police and fire pension reform, maintaining (or increasing) municipal portions of the Local Government Distributive Fund and the Responsible Bidder Ordinance as key legislative concerns facing municipalities.

- Senator Pam Althoff Meetings on Assessment Legislation
 Senator Althoff convened two meetings on January 15 and 30 to discuss potential
 legislation that seeks to provide additional uniformity and transparency to the tax
 assessment process. Member Tom Weber, Assessor Marty Paulson and I attended as
 well as McHenry County officials, some township assessors and community activists.
 Althoff's legislation is currently being drafted and has not been filed yet.

Paula Trigg and I met with IDOT Secretary Schneider to discuss Lake County transportation needs including the four priority projects that we identified late last year.

It 's important for all users of private wells to have their drinking water tested annually to see if it meets the minimum drinking water standards. In observance of National Groundwater Awareness Week in March, the Lake County Health Department will offer reduced water testing rates. Between March 3 and 13, water samples can be brought to the Lake County Central Permit Facility at 500 W. Winchester Road in Libertyville between 7:30 a.m. and 3:30 p.m., Monday through Thursday. During this time, the normal \$16.00 analysis fee for testing for bacteria and nitrates will be reduced to \$10.00 for residents who rely on a private well for their drinking water. Lake County Partners Report.

At the start of 2014 Lake County Partners has seen a continuation of the momentum that has occurred over the past 12 months. So far this year Lake County Partners worked with 24 prospects seeking information on Lake County properties appropriate to their specific project parameters. Projects were mostly industrial uses but did include one office and 2 mixed-use searches. Building searches ranged from 3,000 to 300,000 square feet of space. Lake County Partners also assisted in two land site searches.

Once again this year, Lake County Partners is working with Lake County home rule communities to allocate their Private Activity Bond volume cap to the Lake County pool, which is hosted by the Village of Buffalo Grove. This enables Lake County to continue to have a pool of Industrial Revenue Bond funding for projects, as well as a pool of funding for Low-Income Housing projects.

Lake County Partners and the Lake County Municipal League will be presenting a forum on "Hot Topics in Municipal Finance" on the morning of Wednesday, February 19th from 7:30am to 9:30am. This event will provide an opportunity for local communities to stay ahead of Municipal Finance Trends for 2014 and learn how to maximize the effectiveness of their municipal finance strategies.
