6.1 09-1405

Resolution approving Proposed Bylaw Changes for the Lake County Affordable Housing Commission.

- The Affordable Housing Commission of Lake County (AHC) requests approval to change certain items of the current Bylaws of the Lake County Affordable Housing Commission ("Commission").
- The HCS Committee has been provided follow-up information, requested at the April 7, 2009 meeting, related to the requested changes and their rationale. See attached documents.
- AHC is requesting approval to:
 - Change the Commission's general power "to appoint a minimum of a simple majority of members" and allow the Commission "to appoint a minimum of 25% and a maximum of 49% of the AHC Board of Directors". This would remove the Commission's Instrumentality of Government status allowing AHC to apply for certification as a Community Development Financial Institution (CDFI).
 - Eliminate the Commission's Public Education and Advocacy and Legislative Affairs committees.
 - Change the Commission's goals that specify work plans related to public education and legislative activities.

Joint Resolution authorizing the execution of the necessary documents to submit a substantial amendment to the 2008 Annual Action Plan for the Homelessness Prevention and Rapid Re-Housing Program (HPRP).

• The U.S. Department of Housing and Urban Development (HUD) announced the

availability of approximately \$1.5 billion for the Homelessness Prevention & Rapid Re-Housing Program (HPRP) as part of the American Recovery & Reinvestment Act (ARRA).

- Lake County is eligible to apply for \$1,057,106 of this funding by submitting a substantial amendment to its 2008 Annual Action Plan.
- Staff has sought input from homeless service agencies and other stakeholders to determine an appropriate plan for the use of funds.
- Subrecipients will be determined at a later date through a competitive application process.
- The plan must be turned in to HUD by May 18.
