Discussion of potential FY 2011 State Legislative Initiatives.

Amy McEwan, Sr. Asst. County Administrator and Barry Burton, County Administrator updated the committee on three legislative items.

1. House Bill # 5055 Foreclosure Sales. Lake County is working on an amendment with the Sheriff Association and a group of lawyers. Lake County is seeking compromise language.

2. Fox Waterway Agency/Sheriff Marine Unit. This would allow Lake County to recover some of the costs associated with patrolling the lakes by instating a Public Safety user fee.

3. Administrative Judication - a bill passed last session - Lake County is researching how it could be implemented. The analysis will be more complex and more detailed because it impacts court fees, court calendaring and scheduling.
