*Derek Blaida, Strategic Advocacy Group, provided a summary of the State of Illinois 2025 legislative session thus far. Mike Grady, Strategic Advocacy Group, provided an update on state legislation of interest to Lake County. Topics included: Property Tax Appeal Board (PTAB) meeting locations, data sharing between township supervisors and the Chief County Assessment Officer, and extended producer responsibility (EPR) bills pertaining to food waste and household hazardous waste. *Matt Meyers, Deputy County Administrator, introduced Robin Grooms, Sustainability Programs Manager, who provided an overview of Illinois HB 3349, Powering Up Illinois, which would require electric utilities serving a certain number of customers to upgrade electrical distribution systems. Discussion ensued. The consensus of the majority of the Committee was to support the bill.*

*Ms. Grooms also provided an overview of Illinois SB 2473, Clean and Reliable Grid Affordability. Discussion ensued. The consensus of the majority of the Committee was to support the bill.*
