Citgo Gas Station hearing and application review for a "waiver" liquor license in unincorporated Lake County.

The court reporter sworn in Yoghesh Patel. Citgo gas station located in unincorporated Antioch is a "waiver" Class G application. Yoghesh Patel will be the owner of the establishment. Mr. Patel owns another gas station in McHenry County, which has not had any issues or violations.

Mr. Patel gave an overview of the process he will be using to check I.D.'s.

Dan Brown, State's Attorney, asked questions regarding the establishment and application. Mr. Patel stated the closing for the gas station is planned for the end of

February. The liquor license was approved contingent of the sale for the Citgo located at 27161 W Grass Lake Rd, Antioch, IL 60002.

7.2 20-0183

Route 60 Roadhouse hearing and application review for a "waiver" liquor license in unincorporated Grayslake.

The court reporter sworn in Fritz Larsen and Jennifer Schaller. Mr. Larsen stated he owned other liquor establishments in McHenry County and that he applied for a Class A/B License. The location was purchased from Brandy on the Rocks in unincorporated Grayslake. Mr. Larsen gave an overview of the remodel of Route 60 Roadhouse.

Discussion ensued on the interpretation of the ordinance.

Kyle Braeswicz, Sheriff's Department, gave an overview of the arrest in 2016 with Mr. Larsen. There were 19 calls to the police in regards to Half-Time Bar, one of the establishments Fritz Larsen owns in McHenry County, in 2019.

Chair Hart asked for an continuance of the hearing for further research in 2018 until February 24.

Jennifer Schaller applied for the manager position at Route 60 Roadhouse. Ms. Schaller was granted a manager position.
