Joint resolution authorizing the execution of Program Agreement No. 407107 with the Illinois Criminal Justice Information Authority and an emergency appropriation of \$26,667

for the 19th Judicial Circuit "Community-Based Transitional Services for Female Offenders Program."

Presented by Sr. Asst. County Administrator Amy McEwan who spoke about the cuts in funding of probation by the State. Ms. McEwan noted that the courts are evaluating their programs and because of budget constraints, they are not going to be able to move forward with this program.

Marci Jumisko, Court Administration, advised that this program had been studied by Loyola University and they found that the program had no real impact on recidivism in the long term or in even getting people into the treatment services program.

Ms. Jumikso introduced Rose Gray of Adult Probation and noted that she will be taking over as Director in December. Ms. Gray spoke to the Committee about gender specific programs offered by Adult Probation. Ms. Gray then took questions from the Committee.

Ms. McEwan advised that there will be a presentation on detailed programming in the probation area at the CJCC meeting on November 12 at 8:30 a.m. in the Assembly Room for anyone interested in attending.
