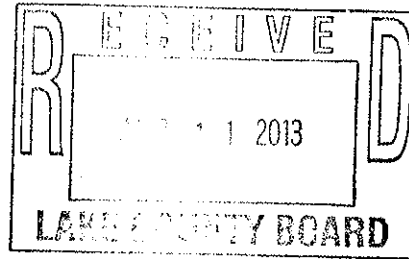

Dear Chairman Lawlor,

Please accept this letter requesting two reappointments to the Board of Trustees for the Greater Round Lake Fire Protection District. The term for trustee Richard Kenyon will expire in May 2013.

The Board of Trustees expanded from a three member to a five member Board in 2008. As the result, two additional trustees were appointed by the County Board in January 2008. In accordance with the Illinois Fire Protection District Act (70 ILCS 705/4.01(a)), a lottery was held to establish the terms of the newly appointed trustees. That lottery resulted in Patrick Anderson's term being established until May 2010 and Thomas Buehler's term until May 2011. The Fire District requested reappointment of Mr. Anderson in 2010, but the County Board deferred that appointment until 2011.

Currently, three trustees' terms will expire in 2014. The intent of the Fire Protection District Act is to have only one or two trustee terms expire in a given year. (70 ILCS 705/401(a)) Therefore, please consider reappointing Patrick Anderson to a new three year term expiring in May 2016. This will correct the prior error and provide for appointments as intended by statute. Current trustees and their term expirations are:
