Joint resolution approving the collective bargaining agreement with the Teamsters Local Union No. 714, as exclusive representative of the Law Enforcement Sergeants Division bargaining unit employees of the Lake County Sheriff's Office. Presented by Kevin Lyons. Mr. Lyons highlighted terms of the promotional agreement. He took questions from the committee members. Mr. Burton noted that we had to settle the deputies first and we need to go forward with the sargeants because they do go together. Result of negotions we choose to settle although timing isn't that great because otherwise it would go to binding arbitration. Member Calabresa asked how many people and how much money. Mr. Lyons noted that there are 17 people and they do top out at \$43.77 per hour. Mr. Lyons noted that receipts are required for clothing reimbursement. These are civilian clothes for undercover duty.

A motion was made by Member Cunningham, seconded by Member Gravenhorst, that this resolution be approved and referred on to Financial and Adminstrative Committee. The motion carried unanimously.

9. County Administrator's Report

Chair Nixon noted that she had asked that the committee members receive a weekly jail inmate report. Chair Nixon also noted that she had attended a workshop in Fort Meyers, FL this weekend as a member of the Justice and Public Safety Steering Committee. Chair Nixon reported that one of the topics was juvenile

detention and our program is one of the front runners in this area. Another topic was the re entry program and a lot of couties don't even have this type of program, so we are way ahead. Mental illness in jails was also discussed. Lake County has already moved forward on this with our Mental Health Court. Chair NIxon reported that 4 to 7 billion dollars is being recommended in the stimulus for homeland security. Some of these funds will be coming through the state or perhaps directly to the county; but it is coming.

Sr. Assistant County Administrator Amy McEwan advised that a jail tour is scheduled for Febrary 24 at 9:30 a.m. Discussion followed because that is Election Day and some members were not able to come on that day. Following discussion, it was recommended that we leave the date as February 24 and schedule an additional date, if needed. Chair Nixon also asked that we try to schedule a tour of Depke Juvenile facility.

Ms. McEwan also noted that CJCC meeting is February 26 at 8:30 a.m. in the Assembly Room. Steve Faabri and other staff will be attending to present an overview of the drug court and mental health court program. The CJCC five year plan will also be reviewed.
