I am writing in support of increasing the County Motor Fuel Tax on behalf of the Illinois Road and Transportation Builders Association, whose members design and build transportation infrastructure throughout Lake County. With COVID-19 severely impacting Lake County communities and increasing area unemployment, now more than ever it is important to make significant investment in improving the County's infrastructure and creating good-paying jobs. This is why the 350 members of the IRTBA support Lake County increasing the County Motor Fuel Tax to 8 cents per gallon. Many of those members own businesses, employ workers, live, and perform work in Lake County. Their contributions to Lake County's economy and quality of life cannot be understated.

According to the Federal Highway Administration (FHWA), every \$1 billion of highway spending supports more than 34,779 jobs. Nationwide, nearly 2.2 million jobs are supported by spending on highway and bridge construction. An investment in Lake County's transportation system is an investment in Lake County's COVID-19 economic recovery.

Lake County has a \$1.7 billion funding backlog for necessary transportation infrastructure projects, and this is very apparent when traveling through the County. By increasing the motor fuel tax, Lake County will be able to improve the quality of life of Lake County residents by completing road construction projects that will increase road safety and reduce congestion, air pollution and travel time.

The IRTBA is grateful to the Lake County Public Works Planning & Transportation Committee for the opportunity to submit testimony in favor of increasing the Lake County Motor Fuel Tax to 8 cents per gallon to help make Lake County's roads safer and better to use and to give needed momentum to Lake County's economic recovery.

# Suzi Schmidt, former Lake County Board Chairman March 7 at 12:02 pm

Thank you for the opportunity to address the County Board.

On April 8, 2008 the Lake County Board, on a voice vote, voted unanimously to pass a Resolution that ALL RTA funds would go to transportation projects in Lake County and that the County would continue to fund its portion of the annual budget of the Transportation Department for construction and maintenance to county roads. We did not have the authority to impose a gas tax. The gas tax was not permitted until 2019 as part of the Governor's Rebuild Illinois Capital Bill Legislation. The State's Gas Tax goes up automatically a certain percentage each year depending on the rate of inflation not to exceed 1 cent every year.

In the mid 2000s the County Board went to referendum for a 1/2 cent and then a 1/4 cent sales tax. The public spoke and defeated both referendums. After that the RTA went to the State Legislators and requested a 1/2 cent fee for a variety of services. The RTA asked for support from Metro Counties, an organization that represented all the collar counties, Cook County and numerous counties around the state. As Chairman of Metro Counties, Lake and DuPage County worked with the RTA and the Legislators to agree to give 1/4 cent of the 1/2 cent to the collar counties because we felt that we would not be getting the same service as Cook County. An agreement was made, and that's how we received the funding that we have today. To date, the county has garnered \$362,676,632.00 million in funds for our transportation projects. Yes, almost \$363 million dollars. This money can be used to pay off bonds since the money comes in annually, about \$30 million per year. This gives the County a lot more revenue than a gas tax ever would. Previous Boards were not ignoring transportation issues in Lake County; we set up a plan to fund projects that were and are important.

The taxpayers of Lake County are already taxed to death. There is NO need for a gas tax. I understand that some of the board members and staff plan on raiding the RTA Fund and use it for some pet projects. I urge you to leave this fund alone and stick with your core mission and not venturing into issues that are not the County's job.

Over the years the County has spent millions of dollars on State Road Projects. Instead of imposing a gas tax and raiding the RTA Fund, stop doing State Road Projects and use the \$45 billion dollar Capital Bill funds the state passed for this purpose in 2019. That should take the pressure off of the County transportation budget.

There is absolutely NO need for Lake County Government to impose a gas tax on citizens and businesses.

I hope this finds you well and in good health. I'm writing to oppose the proposed motor fuel tax which goes up for a final vote tomorrow. Many residents across Lake County are low-income and already excessively burdened by high cost of living and low wages. Even a 4-cent fuel tax places undue burden on these residents, especially during an ongoing pandemic. I think it's crucial to make decisions that center their needs.

Many of these low-income residents are frontline workers who rely on their cars for transportation to wage-jobs. They don't get to work from home, and buying a fuel-efficient or electric vehicle is not on the table for them in the same way it may be for higher-income residents. Our low-income residents are most burdened by industry-generated environmental hazards, as well as policies and procedures that neglect their needs. Any environmentally-friendly sounding initiative needs to prioritize their interests. I don't believe that a fuel/user tax or property tax are the only ways to raise the needed infrastructure funds. I do believe that ongoing discussion and review of alternate means to generate the needed infrastructure funds is warranted.

I also want to emphasize that this ordinance was rushed and didn't prioritize public comments. Procedure is critical. I attended the meeting last Wednesday and, despite the knowledge that many members of the public attended the call, public comment was postponed until well after board members continued to discuss. I wasn't able to stay on the call for an indefinite length of time and needed to sign off after 2.5 hours (1.5 of which the committee spent discussing the ordinance amongst themselves).

As a resident of Vernon Hills, it is my sincere hope that Lake County prioritizes the input of its residents, invites public comment prior to committee/board discussion and allows for an adequate time for public feedback prior to voting on ordinances that impact us. Dear Madam Chair Sandy Hart and Board of Commissioners,

The Lake County Transportation Alliance (LCTA) supports the Lake County Board in its consideration to enact a Local Option-County Motor Fuel Tax. We applied the County board for not having raised the property tax levy in the past two years and its efforts to be sensitive to the high property taxes that exist in Lake County. We also know that the top concerns throughout Lake County revolve around improving transportation through road improvements, grade separations for growing freight traffic, reducing congestion, decreasing commute times and improving safety and so much more.

In 1989 a State Bill was passed allowing the collar counties, excluding Lake and Will County, to enact a County Motor Fuel Tax. In 2019 that Bill was amended to include Lake and Will County, shortly after Will County enacted its own MFT. Lake County remains the only collar county that has yet to enact any local MFT.

A local MFT can only be used for transportation improvements pertaining to county highways. The current funding from other sources to our county does not support the backlog of projects for our public highways. The Lake County Board has already determined that a key goal to the county's future is to create a multi-modal transportation system that improves the quality of life, increases safety, reduces accidents and has an environmental value. We are aligned in this mission for the County. LCTA recognizes the economic challenges that have been strained by the pandemic making this action more difficult but we believe that the local MFT offers a means of dedicated funds that ensure progress of critical Transportation Improvement Projects (TIP) throughout the entire Lake County region.

LCTA has reviewed a 2015 study.

- Increasing the gas tax does not result in a commensurate penny-to-penny increase in the retail price motorists pay at the pump, a study of the market impacts of five state gas tax increases enacted in 2013 found.
- The analysis, found, on average, the price for a gallon of regular gasoline the day after a state gas tax increase goes into effect only reflects about 22 percent of the new levy. A month after enactment, only about a third of the levy shows up in the pump price, she says, and thereafter, it is not a significant retail price factor.
- The study also found that since 2005 the average weekly price of gasoline nationally has fluctuated, on average, five cents per gallon. Black says a modest increase in the federal gas tax rate to restore the purchasing power of the user fee—last adjusted in 1993—would likely be "lost" in the week-to-week price fluctuation experienced at the pump.




To the Lake County Board,

This is in reference to the proposal to raise the gas tax in Lake County.

The state of Illinois already has one of the highest gas taxes in the country this is clearly obvious when you look at the Gas Buddy price map, where
Illinois is clearly defined, as well as a handful of other high tax states:



On a more local level, the border of Lake County and Cook County is also clear to see:



It's been said that my county board member has said that the gas tax is "voluntary." Well that's only partially true. Gas taxes are fairly well known to be regressive taxes that affect the lower income groups the most - they don't have the resources to go out and purchase an EV to free them from the taxes.

According to the Illinois Secretary of State Lake County has 3616 electric vehicles - somewhere down the road you guys and the state will have to address how those drivers will be paying their fair share to support the roads. Right now they are freeloading off the backs of the taxpayers on both that and the \$7,000 federal tax credit that they receive to purchase those vehicles. That's a credit that the get regardless of income or vehicle cost - clearly a tax cut to the rich for those Tesla owners!

Here's how it's voluntary to others, like myself: I promise that I will purchase at least 90% of my gas over the border as long as there's a clear difference in prices. That will also include a collateral impact where I will combine other shopping near where I buy my gas. I recently discovered that Antioch added a 1% tax for the eastern part of the village, basically Menards and Walmart. I had been patronizing that Menards, now I will only go to Fox Lake or one in Wisconsin. While you may or may not listen to our votes at the polls or our comments, we do have the freedom to vote with our pocket books. The Board should be demanding that our elected representatives in Sprngfield get a proportionate share of the revenue from the states' gas tax increase sent back here - our share was nowhere near what it should've been for the third most populated county in the state. The board also shouldn't have gone against the voter's wishes for the route 53 / FAP 342 extension in Lake County. That a project that was clearly wanted by the voters in the referendum and that should've been built 40 years ago!
