Measles Update

As of April 5, 2024, the Chicago Department of Public Health has identified 57 cases of measles in Chicago.

On March 23, 2024, the Lake County Health Department confirmed a case of measles in a Lake County resident. To date, this is the only confirmed case of measles in Lake County.

Measles is a serious respiratory infection that causes a rash and high fever and can lead to pneumonia and other complications. Measles spreads easily through the air when an infected person breathes, talks, or sneezes.

While cases of measles are exceedingly rare due to high vaccination coverage from childhood, reports of measles cases have recently been increasing internationally and in the United States.

The measles-mumps-rubella (MMR) vaccine is extremely effective at preventing measles and remains by far the best protection against measles for people of all ages. Learn more

Autism Acceptance Month

April is Autism Acceptance Month. The theme, "Celebrate Differences," promotes autism acceptance, celebrates an individual's unique differences, and fosters inclusivity and connectedness.

Autism Spectrum Disorder (ASD) is a developmental disability caused by differences in the brain. People with ASD may behave, communicate, interact, and learn in ways that are different from most others.

If you think your child might have ASD or there could be a problem with the way your child plays, learns, speaks, or acts, contact your child's doctor as soon as possible and share your concerns.

Research shows that early intervention services can greatly improve a child's development. To make sure your child reaches their full potential, it is very important to receive services as soon as possible
