AN ORDINANCE deleting certain properties from proposed Special Service Area Number 16 of The County of Lake, Illinois.

• PREAMBLES •

WHEREAS

- A. On June 11, 2013, the County Board (the "County Board") of The County of Lake, Illinois (the "County"), adopted Ordinance No. <u>13-0647</u> (the "Proposing Ordinance"), which proposed establishing Special Service Area Number 16 ("SSA #16") to pay for the costs of improving and extending the existing water supply system to provide access to Lake Michigan water, in the area legally described in the Proposing Ordinance.
- B. Pursuant to the Proposing Ordinance, a public hearing (the "Public Hearing") was held on August 13, 2013, after giving proper notice (the "Public Notice") as required by the Special Service Area Tax Law, as amended (the "SSA Law").
- C. The Public Notice included the legal description and the permanent tax index numbers ("PINs") of all of the properties to be included in SSA #16.
- D. The Public Notice included four (4) properties (the "Parcels") that were inadvertently included in the legal description and listing of PINs.
- E. The owners of the Parcels have requested that their properties be excluded from SSA #16.
- F. The County Board may delete properties from SSA #16 in accordance with the SSA Law, which provides:

At the public hearing or at the first regular meeting of the corporate authorities thereafter, the municipality or county may delete the area from the special service area. However, the special service area must still be a contiguous area as defined in Section 27-5.

- G. The September 10, 2013, County Board meeting is the first regular meeting of the County Board after the Public Hearing.
- H. Notwithstanding the deletion of the Parcels from SSA #16, SSA #16 will remain a contiguous area.

NOW THEREFORE It Is Hereby Ordained by the County Board of The County of Lake, Illinois, as follows:

- Section 1. Incorporation of Preambles. The County Board hereby finds that all of the recitals contained in the preambles to this Ordinance are true, correct and complete and does incorporate them into this Ordinance by this reference.
- Section 2. Deletion of Properties. The Parcels listed on Exhibit A attached hereto are hereby deleted from SSA #16. The legal description for proposed SSA #16 is hereby revised to remove the Parcels, and the list of PINs, list common addresses and map of SSA #16 shall be revised accordingly.
- Section 3. Severability. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

Section 4. Superseder and Effective Date. All ordinances, resolutions or orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict hereby superseded, and this Ordinance shall be in full force and effect forthwith upon its adoption as provided by law.
