FOURTH AMENDMENT

to the

PROFESSIONAL SERVICES AGREEMENT

GENERAL ENGINEERING SERVICES

This is an agreement, by and between the LAKE COUNTY STORMWATER MANAGEMENT COMMISSION, 500 Winchester Road, Suite 201, Libertyville, Illinois 60048 (hereafter called SMC) and BLECK ENGINEERING COMPANY, INC., 1375 N. WESTERN AVE., LAKE FOREST, IL 60045 (hereinafter called CONSULTANT) to amend the professional services agreement between them which was executed by the Lake County Stormwater Management Commission on May 2, 2022 (the "Agreement"):

RECITALS

WHEREAS, the original Agreement between the parties provided the payment to CONSULTANT shall not exceed \$531,312.90; and,

WHEREAS, the FIRST Amendment to the Agreement provided the payment to CONSULTANT shall not exceed \$689,260.55; and,

WHEREAS, the SECOND Amendment to the Agreement stated that the Agreement for Professional Engineering Services shall be effective through April 6, 2025; and,

WHEREAS, the THIRD Amendment to the Agreement provided the payment to CONSULTANT shall not exceed \$875,295.55; and,

WHEREAS, paragraph 8 of the Agreement permits amendment and modification via the parties' express written consent and the parties desire to express their agreement to increase the Agreement's not-to-exceed value to accommodate the changed cost requirements;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree that paragraph 1 of the Agreement between them shall be stricken in its entirety and replaced with the following:

 For an approved cost estimate on a work assignment, the SMC agrees to pay the CONSULTANT on a time and material basis with a <u>total not to exceed contract value of</u> <u>\$1,109,295.55</u>. The fees and costs charged to the SMC for work performed will be in accordance with BLECK ENGINEERING COMPANY, INC. Standard Charges as described in EXHIBIT A. The current summary of estimated expenses for all work done or yet to be completed is attached as EXHIBIT B. IN WITNESS WHEREOF, the parties have caused this Agreement to be executed, as evidenced by the signatures of their duly authorized representative as affixed below.
