- Wholistic approach

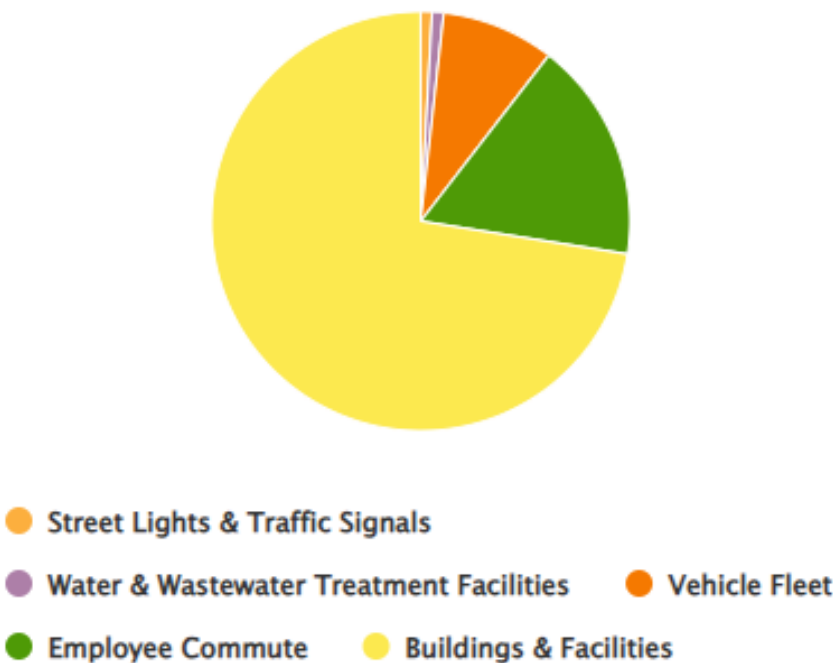


Baseline Emissions

CO₂e By Category



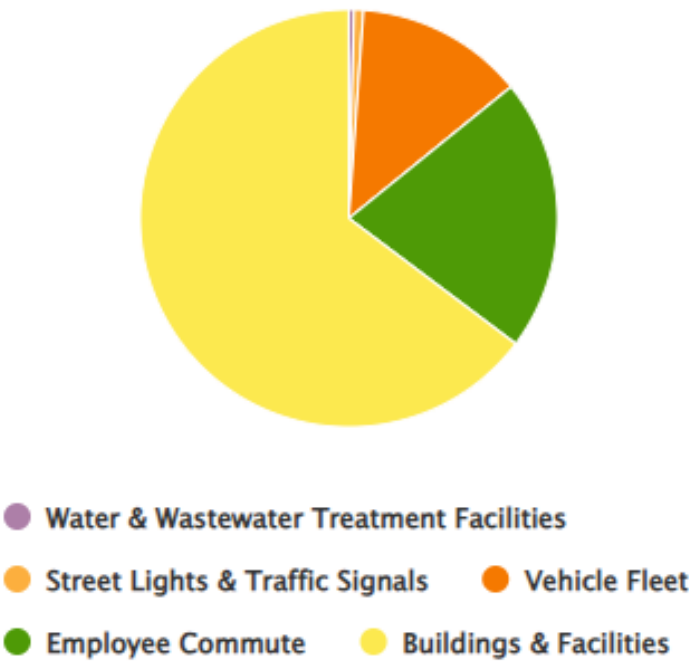
2024 Greenhouse Gas Emissions



- In 2024, Lake County produced 27,623 MT of CO₂e.

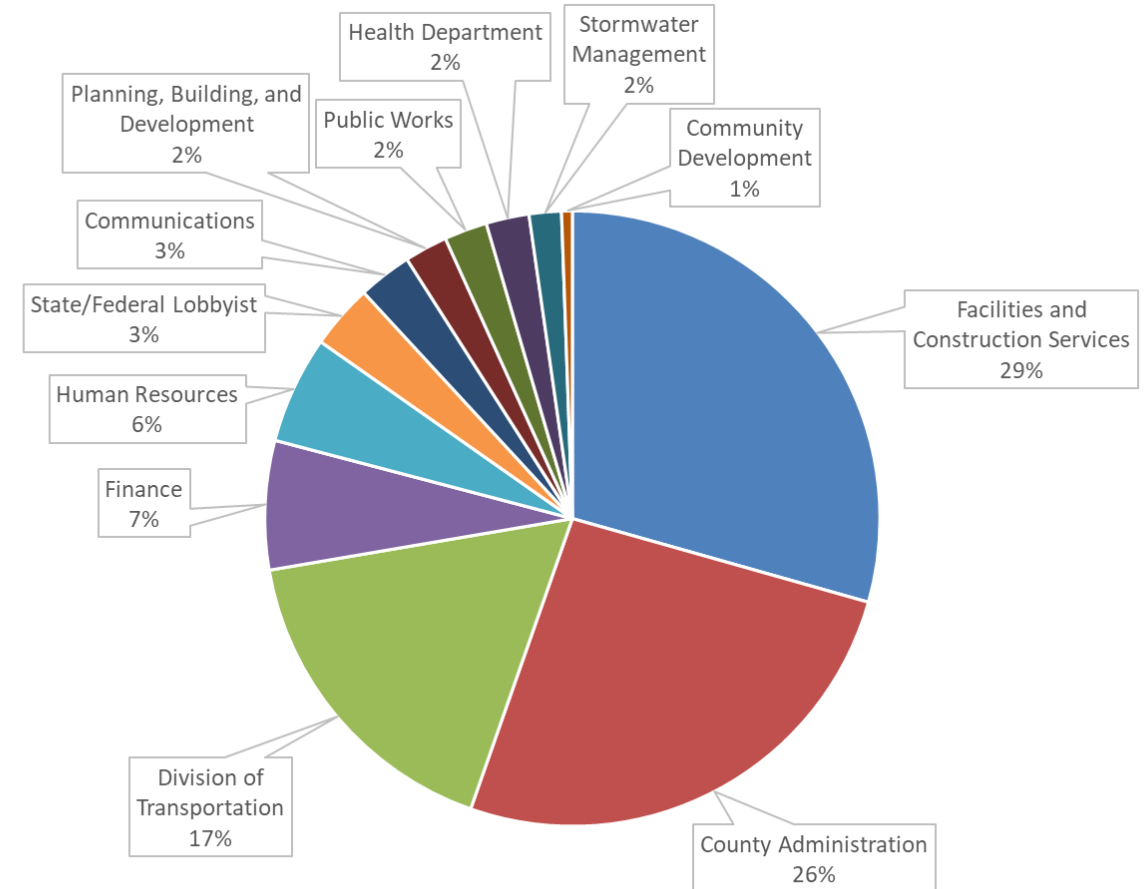

Content Summary for 2025 Reporting Period

- **22 Goals**

- **38% of strategies have a specific timeframe for implementation**

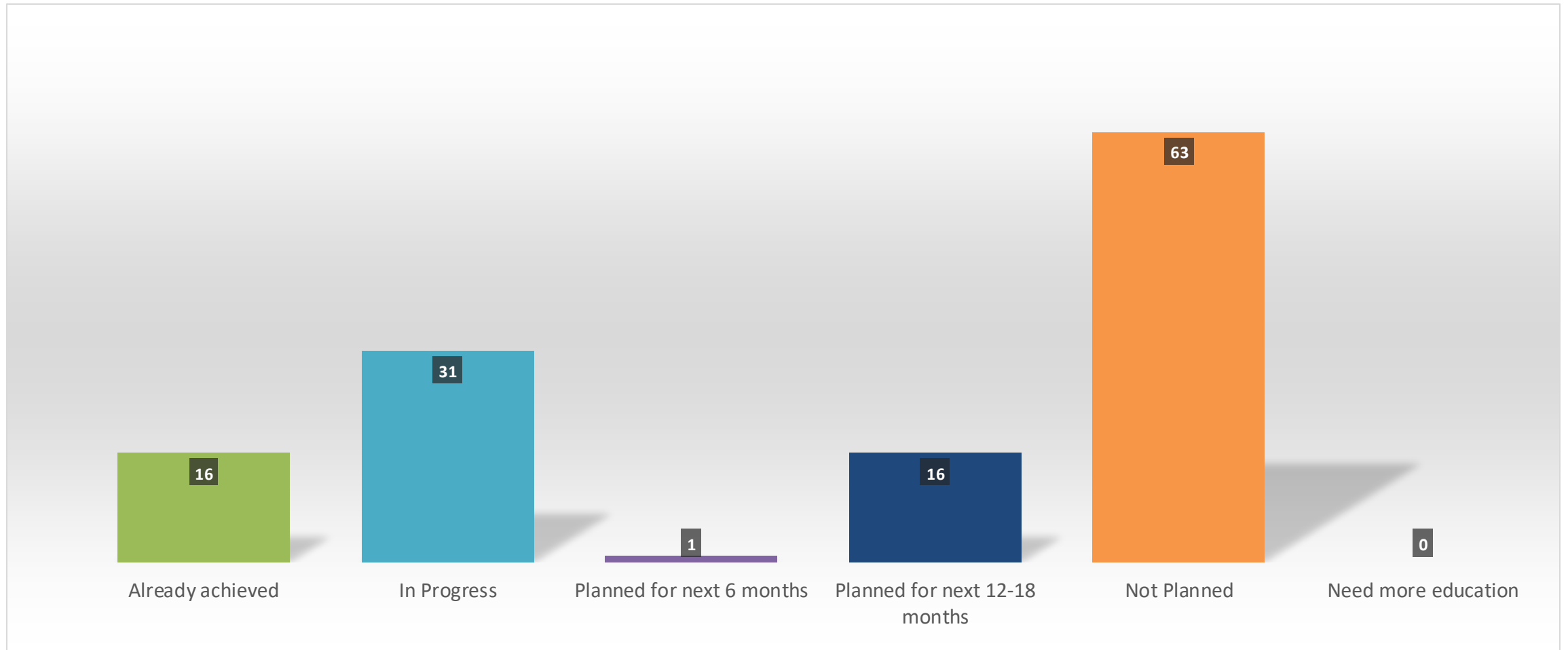


Annual Reporting Process

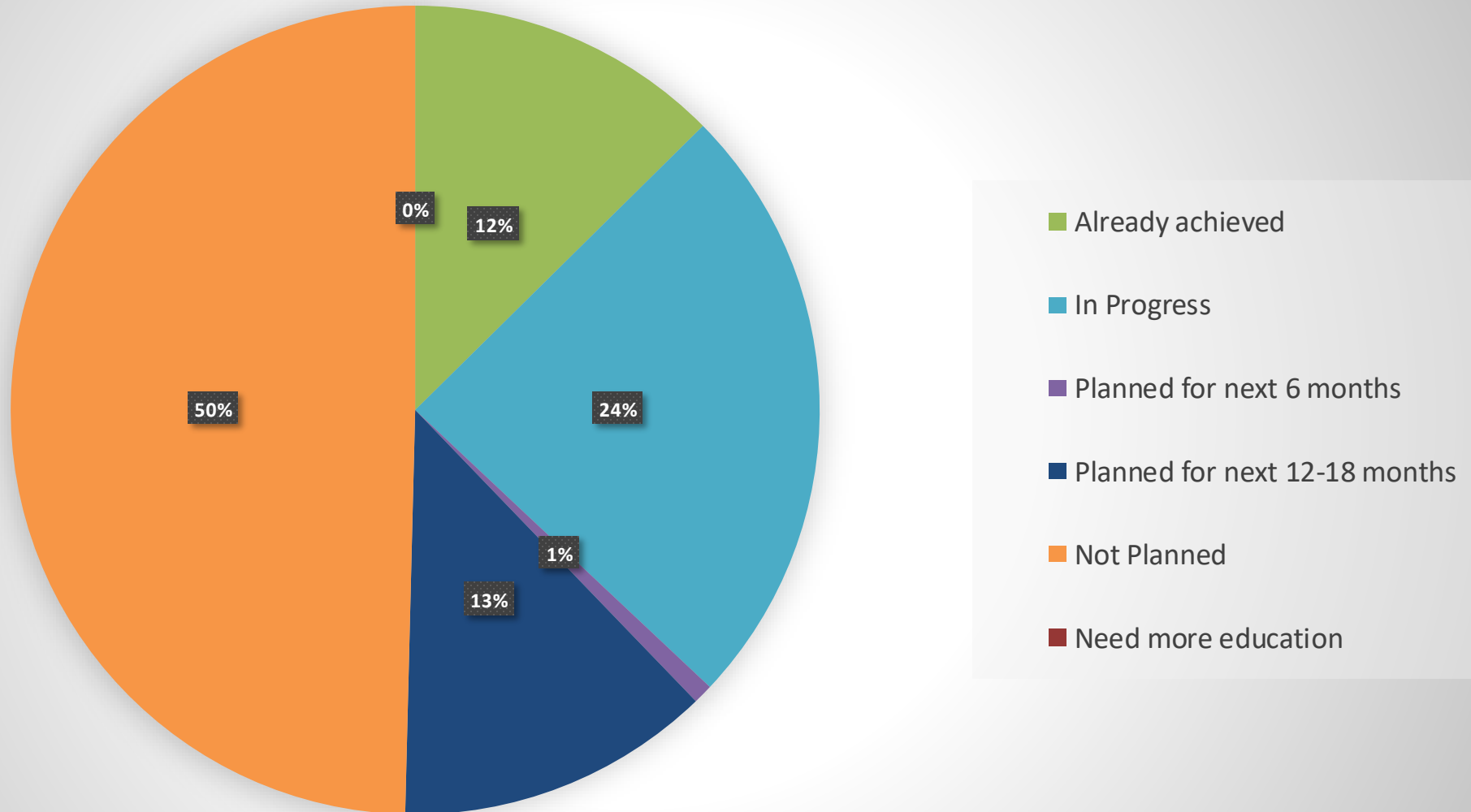


- Every strategy in the Roadmap to Decarbonization has been assigned to a Head Responsible Party
- The role of the Head Responsible Party is to keep a record of progression and report strategy progress annually on behalf of all the groups working on that strategy through a survey
- The total reporting period (30 days) was enough for the Head Responsible Parties to conduct reporting
- Training materials for reporting received positive feedback on their clarity and effectiveness
- This report method will repeat annually

Strategy Completion Rate

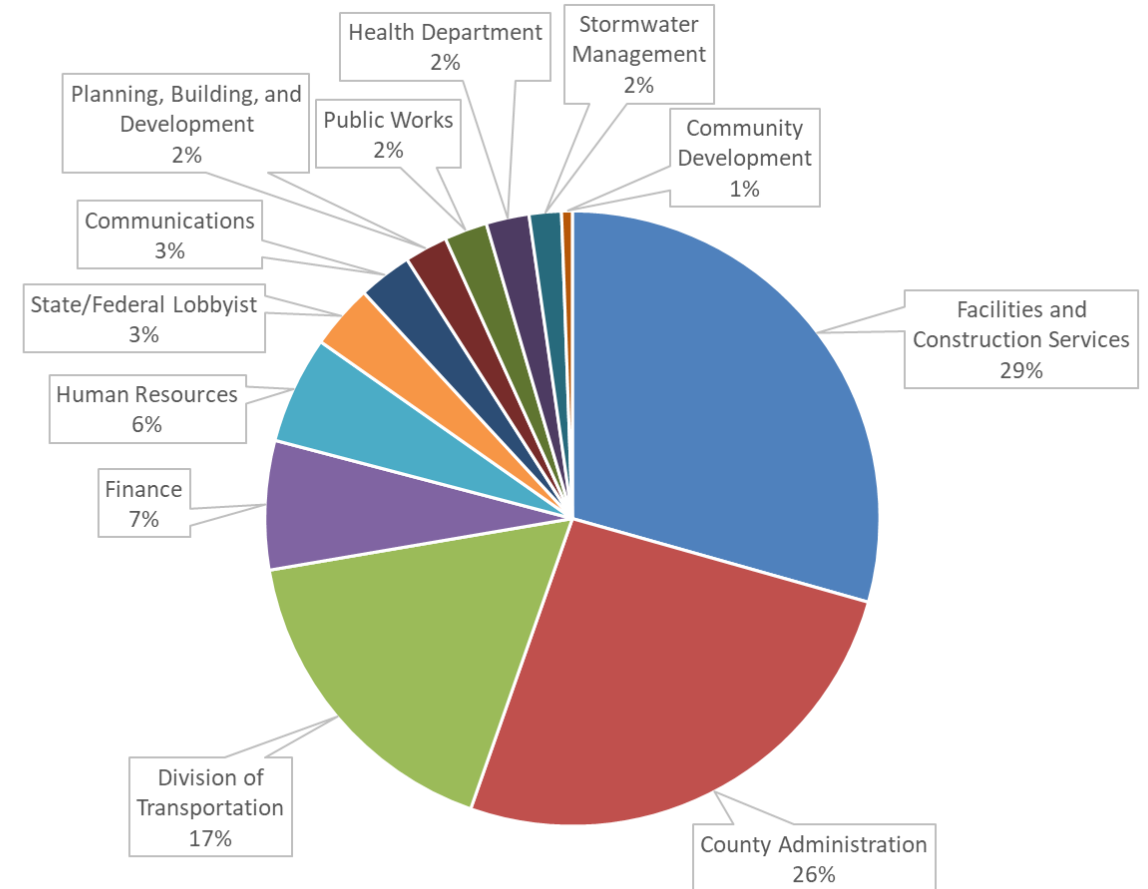


Suggested Changes

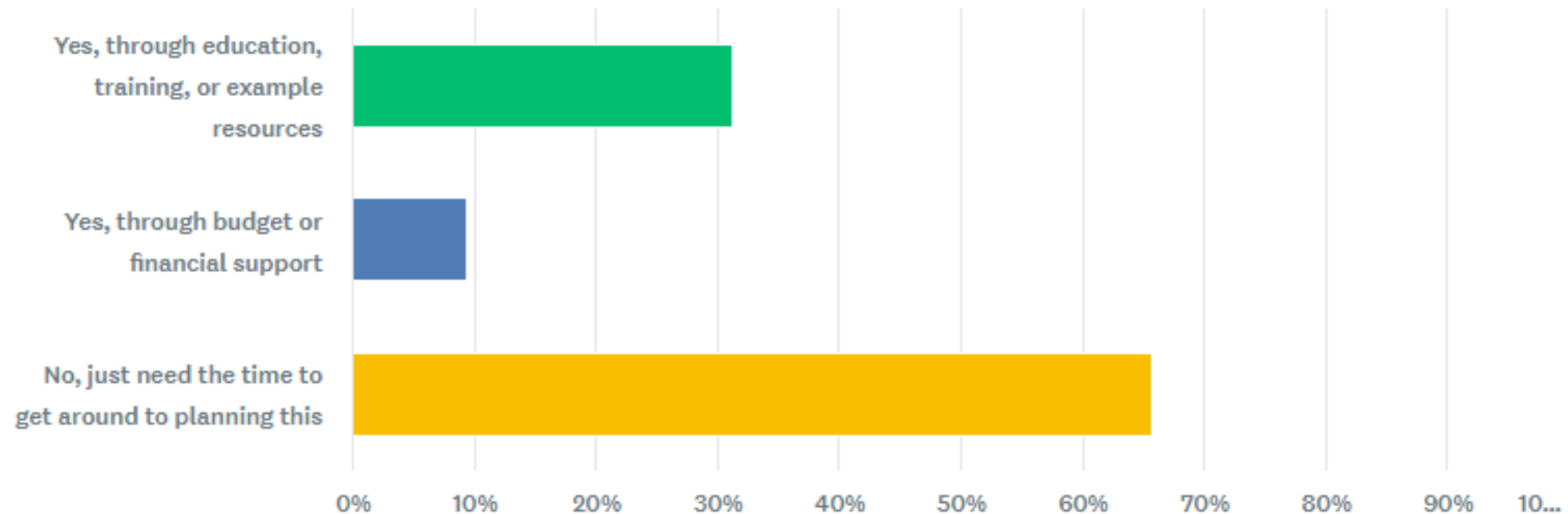

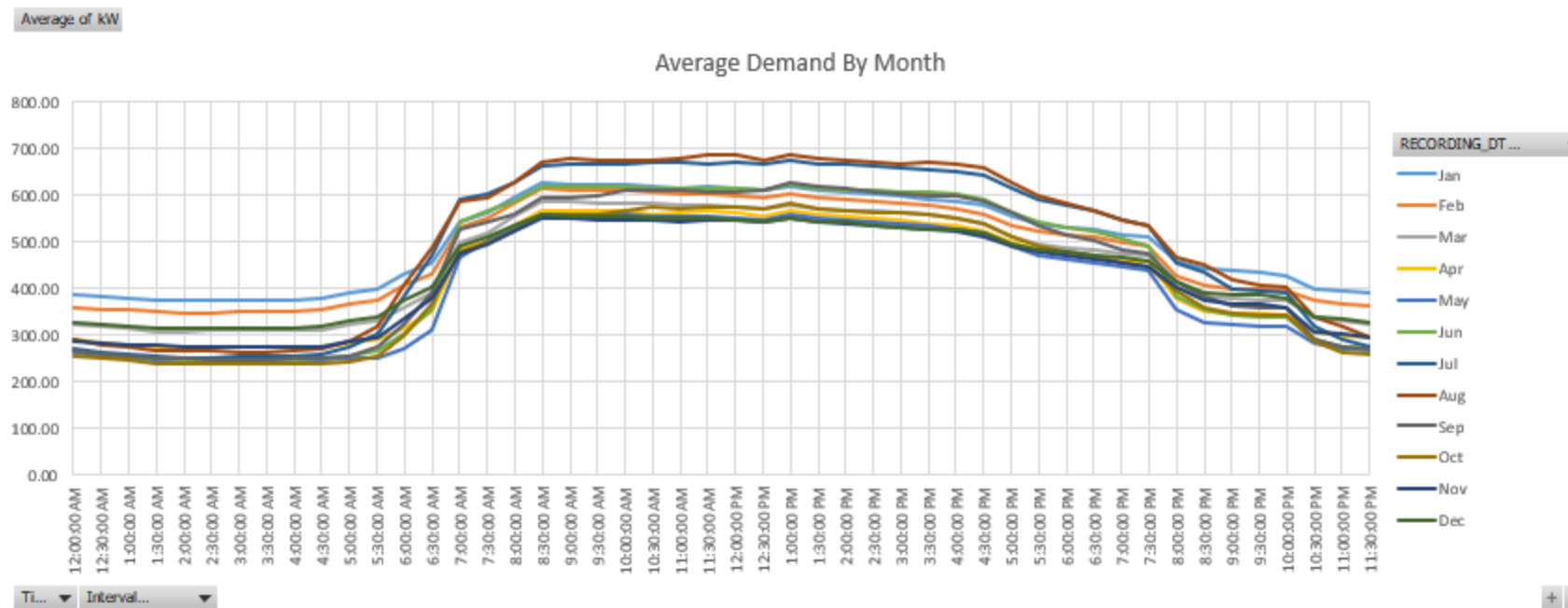
