- The PY22 AAP includes annual funding recommendations totaling \$2,880,838 CDBG, \$2,356,220 HOME, and \$220,057 ESG.

#### 6.4 23-0569

Presentation - Prairie State Legal Services - Fair Housing.

Maya Ziv-El, Fair Housing Attorney with Prairie State Legal Services, presented on the Fair Housing Act (FHA), and new Fair Housing law changes made in 2023. The FHA is a federal law the prohibits discrimination based on disability, race, sex, color, national origin, religion, and family status. Illinois Human Rights Act adds additional protection including: age, marital status, military status, order of protection, pregnancy, sexual orientation, arrest record, and the newest addition, source of income. FHA's dual goals are to end housing discrimination and promote diverse and inclusive communities.

#### 6.5 23-0566

Approval for Lake County to serve as the Responsible Entity and complete 24 CFR Part 58 Environmental Review Records (ERRs) for recipients of Congressional Directed Funds.

- The U.S. Congress has appropriated funds directly to recipients for projects located in Lake County, IL.
- An Environmental Review Record (ERR) must be completed by a Responsible Entity for the appropriated funds.
- The attached agreement defined the terms and conditions for Lake County to serve and the RE and complete ERRs for recipients with projects located in Lake County not meeting the definition of a RE.

Dominic Strezo, Senior Grant Manager, presented that Lake County would serve as the responsible entity to complete environmental reviews for recipients of Congressional Directed Funds. There is a very specific definition within Part 58 on who can certify that report and not all the recipients meet that definition. Those that do not meet the definition

have been advised to reach out to the county or someone meeting the definition to do the survey for them.
