Mr. Rovang,

I read about the public information meeting being held May 9th. Though I do not live in this area, I support the decision of Stevenson High School area residents to restrict the burning of landscape waste.

I live in unincorporated Lake County in Fremont Township, and I would support our neighborhood (Sylvan Lake) also banning or restricting the burning of landscape waste. Several of my neighbors burn on an empty property lot across the street, and one pile of leaves and other landscape debris is dangerously close to the utility power pole at the corner of Hillside Lane and Crescent Drive. Another pile (on the other side of the lot), one time it caught the roadside grass & weeds on fire and the spreading fire came very close to a parked car. These neighbors live on the lakefront side of Crescent Drive and in my opinion, they do not have access to water to put out their fires if there is a sudden blaze. I think it's both inconsiderate and dangerous to burn on the vacant lot.

Personally, I no longer burn my leaves – I put them in my compost bin or rake them over my flower beds as mulch. If necessary, I would buy paper landscape bags and put these on the street for garbage pick-up. Better to dispose of leaves this way than to create billows of smoke and force the neighbors to close their patio doors and windows until the fire burns out. This is what I was required to do when my adjacent neighbor burned leaves on a windy day – the smoke blew directly towards my house and I could no longer have my doors or windows open.

I'm surrounded by those who enjoy burning their leaves while I do not.

We were not able to attend the Public Information Meeting for the proposed burning ban for residents near Stevenson High School, so we are writing to present our position. We read the letter that came with the notice, as well as the article on the Buffalo Grove Patch web site which covered the meeting. That is as informed as we are.

As residents of Krisview Acres for seven years, we have done our share of burning. In the past, we burned all landscape waste, including leaves and logs. Now, we compost most of our waste, and burn mostly weeds and large waste that does not compost well.

We follow all the rules. We call the fire department before we burn. We do not burn green or wet waste, but rather wait for it to dry. We do not burn on windy days. We burn on the weekends. We always have a hose ready to douse any stray ashes.

Therefore, it is quite distressing that this ban is being proposed.

The smoke from our fires does not reach the school. We are two streets down, and just a few lots from Route 22. School is not in session when we burn, and the athletic fields, if occupied, are farther north off Route 22.

There are other facets of the proposed ban with which we have issues.

The reason behind the ban is the lingering smoke on campus and athletic fields. Yet you are allowing burning in April, May, October and November--all months that school is in session and students are present. Even with burning restricted to weekends and evenings, there are many sporting events during those hours. Yet you aren't allowing burning in the summer months when there are fewer students on campus and school windows are closed because the air conditioning is on.

You propose to allow burning on weekdays after 7:00p.m. The sun is already down by then during those months. Yet currently, burning is not allowed after dark. Why the change? Is it wise to allow burning in the dark?

One resident (quoted from the meeting), said the students do not have a choice of attending Stevenson High School. How very UNTRUE that is. Nobody forced anybody to move into the Stevenson district. Nobody forced these parents to send their children to public rather than private school. So to say their students do not have a choice in being exposed to the lingering smoke because they HAVE to attend Stevenson, is far from the truth. My husband and I moved to Prairie View to keep our children in Stevenson. We do not like the traffic. We do not like the taxes. But it is something we live with because it was our choice to move here.

We moved into our unincorporated area because of the few freedoms we have here that are not allowed in surrounding areas. Yet you are slowly taking these away from us.

Another concern is how these rules will be enforced. According to the article, it will be complaint based. Therefore, if nobody complains, we can do what we want. Although that's beneficial to us, it really bothers us for you to have that attitude. If you are going to ban something, then it should be enforced.

This is a large problem for this area. Nothing gets enforced unless someone complains. And even then, there is no guarantee. We have called to complain about drivers using our streets to cut through and avoid traffic on Rte 22, and to use Brockman and Menna as an access to turn left onto Rte 22 because they can't turn left from Prairie any more. I was told that the "Local Traffic Only" sign was merely a deterrent, and it can't be enforced. So when I walk my dogs in the neighborhood, I am constantly looking over my shoulder to watch for cars flying through. Plus, they turn left from Prairie onto Brockman every morning, despite the Left Turn ban from 6:00am to 9:00am.

I guess our voice isn't big enough to warrant compliance. And now, you want to punish us when we are not the ones doing anything wrong. Once again, it is punishing all because of the actions of the few. How very, very unfair. We are going on record as opposed to the ban. We agree that those adjacent to the school should NOT burn while school is in session, or athletic fields are occupied. Why not just stop it at that? It's just plain common sense.

Mr. Rovang,

I had planned to attend the 5/9/11 meeting at Stevenson High School regarding the "Burning Ban" until I read the article in the Chicago Tribune (April 27, 2011). It looks to me like this is already a cut and dried decision. The "city of Stevenson" has once again manipulated the county and township branches of government.

We have lived in Prairie View for thirty-seven years. Two years in the apartments on Apple Hill and thirty-five years in Krisview Acres. We have never seen smoke obscuring traffic on RT. 22 or Prairie Road and Port Clinton. We have had views of each of these roads from our two locations over time as we border the farm field and have had a clear view from 1976-2011.

All of us in Krisview have massive amounts of falling leaves to dispose of in the fall (September-November) and again in April and May. Falling branches from spring through fall due to high winds require removal with few alternatives for disposal. We have few alternatives for disposal. Only those of us on Lee Lane that border the Stancliff field have current access for

disposal of our leaves in the field after the crop is harvested, and this is not a guarantee year to year. Weather often delays the harvest to well into November. Piling up leaves until the field is available only leads to piles of wet leaves that do not dry well. Burning is necessary at these times. We feel that the Krisview subdivision should not be included in this exclusion zone. We are far enough away that any smoke is greatly diluted shortly after leaving Krisview.

SOME OTHER THOUGHTS

So Stevenson is now concerned with the health and safety of their student body and guests. My have times changed since the 90's, when they put up a fence along their western border and made the kids from this area navigate RT. 22 to get to school. If they tried to scale the fence they were threatened with suspension. That fence came at the time right up to the busy highway, even blocking a sidewalk from the west. We could get NO VALID answer from the Vernon Township or Lake County as to the mystery of how Stevenson could cut off access via the easements, which are shown to exist on the county/township plats for the subdivisions, from Prairie Road and across Apple Hill Lane. It was a mystery to us how they could, at that time, do that. When a parent from Prairie Road called the High School about the hazard along RT. 22, they were told that maybe Stevenson could provide bus service, for the area. Not that we have allowed or cashed in on student parking in our driveway, but the recent mailings from Lake County about this seem odd. If a homeowner wants to allow a student to park on their private property, what is the big deal? This is not running a parking concession.

The purpose of this letter is to object to any burning restrictions by Stevenson High School. I burn throughout the year leaves, branches, & trees. My wife has asthma and has never complained about the smoke bothering her. The school is centrally located on the site and any smoke is quite diluted before reaching it. Outside makeup air is minimal at the school.

The purposed restrictions are unduly harsh. Two hours is not sufficient time to completely burn.

The existing fire procedures allow for the fire department to request any fires to be put out if the smoke is bothering anybody. That is sufficient to control any real smoke problems. Has the school called the fire department?

An activist student action may sound great in the press, but the health concerns are overstated.

Before any restrictions are enacted, an actual study should be done for a year on what is actually occurring.

Because of warring neighbors, nuisance calls to the sheriff and fire department are going to increase.

To all concerned parties:

I am writing in support of the BAN/restrictions on leaf-burning near Stevenson High School. I am the head Band Director at Stevenson High School, and have been here for 22 years.

I can speak from experience about the problems created by neighborhood waste burning...

I am responsible for the activities of the school marching band, which involves over 350 students.

On days when we have outdoor rehearsals (daytime in August, and several night practice throughout the fall football season), and there is smoke in the air from nearby leaf burning, everyone notices the smell, and is affected by the irritants in eyes and lungs. We have a significant number of students with asthma, and we are concerned, on these days, with the potential for serious health impact on these students when exposed to the smoke. Our concern stems from the knowledge that the smoke can trigger asthma attacks in some individuals.

Also, I share an office with a colleague director on the 2nd floor of the West Campus building. The air handlers on the roof take in the air, and push that through- heated or cooled- to the music department classrooms and offices.

There are days during our neighbors' leaf burning season when the thickness of the odor and smoke is strikingly evident as soon as I walk into the music department and my office. The neighborhood smoke is carried—quite efficiently—into the building, and has an impact on all the 750+ teachers and students in our department. (I am certain that other departments are similarly affected, but I will testify here to just the areas that I have been witnessed affected.)

Frankly, I cannot understand the hesitation to impose an outright ban on landscape/trash burning altogether. That reasonable approach seems to have been taken by all of our surrounding communities. Unless there is a legal issue that prevents the county from imposing such a ban on unincorporated areas, a complete ban would seem the enlightened approach. Failing that possibility, the restrictions as proposed would at least address a portion of a persistent and serious problem.

I was unclear from the information on the Lake County website whether the issue of uncontrolled burning meeting on May 9th was for Stevenson HS area or all of unincorporated Lake County so here are my comments.

I live in unincorporated Lake Villa; south of Grand Ave(Lindenhurst), east of Rt. 83. Uncontrolled burning in this area is terrible. I would say that there is a smoldering fire everyday somewhere in this area. One can seldom open a window. If you are outside for any length of time, you smell like you live in a forest fire or campground.

Burning should be controlled in all of unincorporated Lake county.

These comments I previously sent to Jim Newton; I think that they apply to the issue.....whether just Stevenson HS area or all of Lake County:

I could understand uncontrolled burning if everyone lived on 50 acre farms; but we do not! The area where I live has a lot of houses on 60 foot lots. For most of the year, someone is burning everyday. One can seldom go for a walk without having to somewhere breathe smoke and particulate; both of which are bad for your lungs and your heart.

One can NEVER have a family event without a smokey neighborhood on Sunday. Even God rests on Sunday!!! NO BURNING ON SUNDAYS...period!

Ideally the County should ban burning in Unincorporated areas with lots smaller than 5-10 Acres, but I realize that there is expense involved which in today's economy would most likely be an unpopular choice, but it would be good for our families' health.

The very least the county could do is create an enforceable ordinance that would allow burning on only certain days of the weeki.e. Wednesday and Saturday. Maybe a hundred dollar fine?? Complaints should be allowed to anonymous.

The surrounding incorporated areas do not allow burning. I am really surprised that none of the surrounding mayors have not complained to the County Board about this issue.

Additional comments after reading the Narrative that was on the Lake County website:

"Exceptions are campfires, recreational fires, ceremonial fires self contained outdoor burn devices".....these all need to be defined.

To me, this wording allows everyone to continue to "smolder for days" as they do currently.

I have attached photos of a "recreational fire" on Palm Sunday(on someone's patio) and a "campfire" on Easter Sunday. This is why I think the Exceptions need to be defined and why we should NEVER burn on Sunday!

Out by 7PM... Enforceable? I hope so!

Tree trunks....take a ride in the neighborhood and see how many houses have cut down tree piles in their yards. Some stacked neatly...others just piled.

You will see pallets, furniture, etc in burn piles.

You will also see grass cuttings, I think the county should somehow require mulching or yard waste pickup for grass cuttings. Enforceable?I don't know.

Setbacks are interesting numbers!

I think that it is extremely important that whatever is done, there be a way to enforce this ordinance. I hope that the ordinance is for all of unincorporated Lake County.

I hope that there is some way that burning could be controlled in all of unincorporated Lake County.....I know we have a lot of trees, but incorporated areas deal with it....I just do not understand why it is such an issue in unincorporated areas. We live in the Chicago Metro "EPA area" so I just do not understand how we can continue to have uncontrolled burning....not good for our health.

I know there are ordinances to control this problem.

I have lived in Prairie View for 14 years in the unincorporated area that will potentially be affected if the proposed landscape waste burning regulations go into effect. I personally have never had a problem with the air quality from burning landscape waste anywhere in the vicinity. After talking with my neighbors, they have not either. I have found most of us in the area try to be sensitive to others and take into account weather conditions when burning landscape waste.

The area surrounding Stevenson High School consists of lots 1/2 an acre in size or larger. It is more rural than densely populated and people come here for that reason. All my neighbors have gardens and beautifully treed properties. With all that land naturally comes landscape waste. Burning landscape waste is something that has been done for hundreds of years. I think it is a mistake to interfere and regulate how property owners take care of their landscape waste. Issuing guidelines would be helpful, but to regulate it would be unfair to property owners and a burden on Lake County (and a cost to taxpayers) to enforce.

I read through the proposed narrative and have a few comments if these were to be implemented as guidelines. I think the proposed boundary area is too large. My property is far enough away from Stevenson that burning in my yard would not significantly affect the air quality at the school. I live west of the school (where predominant winds originate) very near Prairie Rd & Brockman Ave. If I were to burn in my yard, the air would have to travel through 10 other 1/2 acre home properties plus a couple of streets to reach Stevenson High School. The boundary for the affected area should be reduced and should take into account obstructions, natural features such as trees, and other impediments to smoke reaching the school.

The proposed boundary does not take into affect the size or use of properties. Some properties in the boundary area are larger than others and may therefore have more landscape waste. Some are more residential while others have more agriculture. It is not fair to restrict everyone as though they are equal. I suggest issuing guidelines for the smaller lots (under 1 acre) since they are closer together and exempt lots over 1 acre.

Re: Leaf Burning Ordinance

The question that should be asked is where is the smoke affecting Stevenson coming from and focus the efforts in those areas. The issue of burning leaves has come up because of two factors, location and climate; meaning the locations of the burnings with Stevenson and Mother Nature. This can be contributed to several of things.

First of all, Stevenson is such a busy place with activities occurring at all times that there may not really be a good time to burn that it would not affect someone. Second, the prevailing westerly winds blow from West to East so any sort of burning occurring on the west side of Stevenson is bound to cross onto the campus. Therefore the problem of burning is more from the west side and not from all directions. Third, the air conditioning system for Stevenson is located on the west side of Stevenson so, again, due to the winds, the smoke crosses and enters the air conditioning system. Fourth, the back yards (typically where people burn) of the homes on the west side run right along the perimeter of Stevenson where, in a lot of cases, the homes on the east side have some buffer e.g. large front yards, Hotz Rd. etc. By restricting the burning times to the homes that have 1 or less acres will capture a majority of the properties running along and around Stevenson.

Based on these reason, it would only make sense for the Board to instill this ordinance or a modified version of this ordinance to those properties that are one acre or less in order to get the most "bang for the buck". This would satisfy a majority of the problem dilemma while displeasing the least number of the residents in the area.

My last comment is that those properties that are 2+ acres need more flexibility to adjust to the weather, available daylight and personal schedules than those who have smaller properties. And that is why it would be unfair for the larger properties to be controlled with same restrictions as the smaller ones. The Board needs to consider how this ordinance affects ALL of the residents. And think of the consequences if people with the larger properties cannot be given every chance in the fall to take care of the leaves and how it will affect appearances of neighborhoods, the amount of leaves that will remain wet and the effects all of the leaves would have to creeks, retention ponds etc.

Here are my comments on the proposal.

I can understand and have no problem to limit my landscape burning to later in the day after most school activities.

I am against the proposal to limit burning to a few months of the year for the following reasons:

1. Mother nature and the weather don't care what day of the year it is to cause tree branches and leaves to fall.
2. Waste Management does not pick up yard waste year round.

I'd be willing to burn less if either the village or Waste Management would pick up landscape waste year round, 365. I recently trimmed some bushes, tied them neatly into short, light weight balanced bundles, and Waste Management put a yellow notice on them, informing me that it was "not their season to pick up yard waste".

Its my opinion that limiting burning to certain months will not alleviate any nuisance from smoke because, as Mother Nature works 365, such waste will only accumulate, to be burned over a shorter duration over the proposed months.

It makes sense to consider others and allow burning on any day of the year, as needed, later in the day, after most outdoor school activities have ended. My daughter Lisa , a Junior, at Stevenson also attended a portion of the meeting and provided her input regarding the discomfort from the smoke and fumes she has been exposed to inside of Stevenson High School with the burning that has been happening adjacent to the school.

I took the initiative back in Nov. of 2010 to address my concerns to the Stevenson High Schools administration and thus this situation is now finally being addressed.

Attached is my letter to the Administration for your reference. The need to impose restrictions and even a ban on burning debris near the school is substantiated by EPA findings. The health hazards and the toxic carcinogenic compounds presented by leaf smoke has to be a top priority for the county board to address.

Your involvement and timely decision making to remedy this situation is greatly appreciated.

I attended a Band Parent Meeting last night. I entered the building at the Sports Center entrance at approx. 7:15 p.m.

The air quality in the building was smoke filled. The smoke odor permeated into the Band Room.

My skin, clothing and hair were saturated with the smoke.

I noticed earlier in the day that in the neighborhood adjacent to the school that some type of yard waste burning was happening and the smoke seemed to be blowing towards the school.

This is definitely an unhealthy environment that my daughter is being exposed to along with the entire population of the school including, students and staff.

According to the United States Environmental Protection Agency “ Burning leaves produces particulate matter and hydrocarbons, which contain a number of toxic, and carcinogenic (cancer-causing) compounds and leaf smoke also contains carbon monoxide.(This is absorbed into the bloodstream through the lungs and combines with red blood cells. This reduces the amount of oxygen the red blood cells can absorb and supply to body tissues

Leaf burning leads to health problems. Since the visible smoke from leaf burning is composed of tiny particles that contain a number of pollutants if inhaled these microscopic particles can reach the deepest regions of the lung and remain there for months or even years. Breathing particulate matter can increase the chances of respiratory infection, reduce the volume of air inhaled and impair the lungs’ ability to use that air.

Since the hydrocarbons are chemicals that can exist as both gases and solid particles some of these hydrocarbons such as aldehydes and ketones, cause irritation to the eyes, nose, throat and lungs. A substantial portion of the hydrocarbons in leaf smoke consists of polynuclear aromatic hydrocarbons, some of which are known carcinogens.”

What in your capacity can be done immediately to remedy this situation?

Is there a local governing body that regulates the adjacent neighborhood that Stevenson Administration can work with to stop the burning.

In many communities open burning of leaves is illegal. Furthermore, the total health, financial, and environmental costs of leaf burning can be quite high. These costs include higher incidences of health problems and increased health care costs.

According to the EPA “a better alternative for homeowners to dispose of their leaves would be composting because is it a safe and environmentally”.

I would appreciate your comments along with the corrective action that Stevenson High School will be taking.

I agree that burning of landscaping waste in the area is inconsistent with the urbanization that has occurred, there are better ways to handle this. Mulching or chipping is much more preferable than burning. Burning causes multiple issues with pollution, irritation of neighbors and interference with other uses of the area.

I would prefer however that burning of landscaping waste be eliminated in all of Vernon Township if not countywide. I live in Vernon Hills (which already bans burning) but my neighbors in Indian Creek are allowed to burn and that they do with gusto. In the spring and fall my neighborhood has a haze of smoke that makes it difficult to breathe, irritates the eyes and makes it difficult to enjoy the nice weather.

We can't open the windows due to the drifting smoke and my wife's allergies are compounded by the pollution the burning of leaves and branches creates.

Please look into the banning of burning in the entire county or at least all of Vernon Township if possible. It is a health consideration, a pollution problem and just plain common sense.

May 9, 2011 meeting held at Stevenson High School

Let me start by saying "produce the documents". We unincorporated residents are being asked, or demanded, to make changes to our lifestyle – we are allowed to face our accusers as the law jargon states. We are entitled to know what is being said, and by whom. Send copies of each and every complaint to each resident/address in unincorporated Lake County. You are, after all, required to uphold the law and ordinances as they apply to your unincorporated residents, too. Not just those who are bringing the complaints that you've deemed so viable as to propose the restrictions in the first place. Also, there was a Chicago Tribune reporter in attendance. His subsequent article states that the Lake County staff was given, at the meeting, a 119-page packet of documents, including petitions signed by about 800 students, along with letters and emails supporting the burning restrictions. This was given to you from a student, a "leader in the effort to restrict burning" the article states - a junior who is at the end of her 3rd year in school but is just now making this an issue. Reproduce and send copies of that entire packet as well to each resident/address in unincorporated Lake County. Freedom of information act applies to us as it does everyone else. We have a right to know what's in those documents – we are taxpayers, too – and are the ones being required to make the proposed

changes. We should be allowed to receive and have ample time to review these documents, before any proposal is made up and brought before any committee meeting. The fact that you already have a proposal made up strongly proves your disregard of the very residents governed by said proposal. How could you so arbitrarily create a proposal without having first inquired as to what your residents thought or wished? All on the basis of a few complaints – 15 is the number mentioned at the meeting. You propose changes on the comments of 15 people? How can you remotely call that fair? The people that are governed by said proposals should have been the first, and only, people allowed to comment or make suggestions. No one else's opinions apply and shouldn't be considered. These proposals shouldn't have been prepared or made up without your even giving any unincorporated residents the courtesy of participating. Your blatant disregard was made clear by your having the May 9th meeting at the school – proposals in hand and distributed so callously to those of us in attendance. That was the first we heard about any proposals. Yet you'd already thought long and hard about this, even checking with other counties and what they do – and then put it in writing! And all in support of the 15 complaints you had received thus far - as stated in the meeting.

The proposals given at the meeting held at Stevenson on Monday, May 9, 2011 are utterly ridiculous. I burn leaves and have for 15 years. On Saturday and sometimes on Sunday....never during the week because I know school is in session. It amounts to maybe 10 days a year....10 days!!! How dare the school and incorporated areas bring such a frivolous complaint. And, shame on you for entertaining the complaint.

You've jumped right to the verdict – when was the trial? Did an investigation take place? What are the results of that investigation? Where is the documentation that supports the proposal being made? Have you or any other government county official attended a football game during a leaf-burning weekend and witnessed the poor visibility and the smoke that is so bad as to make your eyes sting? Did it take hours to leave the parking area due to the horribly poor visibility caused by the smoke? Were you unable to drive due to the stinging of your eyes? Were you wheezing and coughing from the acrid odor of the fumes? Have you or any other government county official been in the school on a Monday morning following a leaf-burning weekend and witnessed smoke or smelled fumes from the leaves that were burned over that prior weekend? And, how do the fumes and smoke enter the building at all? Does the school reverse the intake on their ventilation system so as to draw the air IN on the weekends? It's a sealed unit. I live on a leaf-burning property and the smoke and fumes have never entered my home.

We unincorporated residents pay hefty taxes and choose to live here. We are mindful of the school and burn accordingly – if there is an outdoor function on any given Saturday, then the school should send a notice in the mail to its surrounding neighbors giving the timeframe of the function – and we won't burn during that timeframe. We are after all good neighbors – as the school purports to be. Their request for the restrictions being proposed proves otherwise. They're requesting outrageous restrictions far outside the realm of necessity. There should be no restrictions – other than those few Saturdays an outside function takes place. Other than that, no restrictions are warranted – no time restrictions; no size restrictions. The incorporated

areas shouldn't be allowed to have any opinion, at all – they should abide and endure. They can close their windows on a day a resident is burning. They can move as well. Again, it's only a very few times a year. They choose to live where they do. As do we. And now, they wish to have their code of conduct and their religious beliefs forced upon those of us in unincorporated Lake County who live nearby? No, they cannot do that – they shouldn't even be allowed to have an opinion on anything whatsoever that goes on in the unincorporated areas. And again, shame on you for allowing them their platform. We were required to have our burn pits inspected and approved by the Fire Marshal in order to burn. One resident in attendance at the meeting said he's lived in the area for more than 30 years. He said the fire department has always been in charge of leaf-burning and there has never been an issue. So, why change anything? Leave well enough alone. There is no issue so there is no change required or necessary.

How dare they (incorporated) seek to amend/change/restrict any ordinances...at all. This is akin to them moving to and living in areas surrounding O'Hare Airport - and then deciding they want the right to make changes to the flight patterns and traffic patterns so they aren't affected so much by the noise because it annoys them. No, they have no such rights – they must learn to abide and endure – or move. This is the same type of situation. As for Stevenson – they need to check their ventilation system. Are we to believe that such a state-of-the-art complex has such an inefficient ventilation system that it can't accommodate some smoke and fumes – that it lingers for days and days and affects breathing and causes stinging of eyes? That's ludicrous. It isn't to be believed. It accommodates and dissipates the leaf-burning fumes and smoke. I live on a leaf-burning property – other than my clothes/hair reeking from smoke as I'm actually attending the fire – there is no smell. Clothes go through the washer and I take a shower – that resolves the issue. There are never any fumes/smoke in the house. The idea that the smoke/smell lingers for days afterwards is unbelievable. The smoke and smell dissipate quite rapidly. And, smoke causing visibility issues? That is ridiculous. And, what about the goings on during the week, on the school property – they've had cement drilling and sawing trucks there – that causes huge amounts of dust/debris – they've got workers on the roof almost daily. How can the school assume that their problems arise from the leaf-burning? This whole issue is unbelievable and unwarranted. And again, it's about maybe 10 days a year, if that. They can deal with it and be the 'good neighbors' they purport to be. They've done so since 1965 when the school began – they should continue to do so. Their ventilation issue is likely due to their overpopulation from ever-expanding their complex – an issue we unincorporated residents didn't cause and shouldn't be punished for – leave us alone to live our lives the way we wish to, the way we are allowed to, the way we choose to (we pay taxes, too). We chose to live unincorporated for a reason. Don't presume to force your opinions/rules on the rest of us because you're annoyed or claim health issues – look inward before you lay blame elsewhere. Get an updated ventilation system; put some HEPA filters on it, as one attendant stated. The school began in 1965 - they have chosen to expand and expand their school on land that can't accommodate said growth. They've limited their parking to such that parents are knocking on our doors in the surrounding areas and are begging for a place to park so their child can attend school on time and safely – and have nearby parking to the school. The school doesn't even have enough spaces to accommodate their seniors, let alone any

juniors. That problem was created by the school and their continuing expansion. The school made complaints to Lake County about the nearby homeowners allowing parking in their driveways. They should have instead been thankful their students were safe and nearby. They instead just created a hardship for the very students they claim to care for and represent – on that issue and in this leaf-burning issue.

This proposal being made is a violation of my constitutional right to freedom of religion. These complainers believe in the religion of global warming. That's their belief and they have that right, by law. I believe it's a hoax. They can't force me to convert to believe as they do. It's against the Constitution; it's illegal. You as government county officials are forbidden to impose any restriction on the religion I choose; you are officers of the government and cannot, also per the Constitution. If I were a Muslim – the last thing you'd ever do is try to jam this global warming religion nonsense down my throat – and you know it. I'm being discriminated against and harassed. I'm being forced to convert to this hoax of a religion called global warming. No citizen can presume, nor do they have the right, to impose their religious beliefs onto any other person. It's not right; it's unconstitutional; it's immoral; it's illegal.

To go a step further on the smoke and fumes issue, what about fuel emissions? Or fireplace burning? Or clothes dryers? How far is this proposal to extend? Any students claiming to be affected are so affected for such a short period of time – and for such a few days and instances. But again, not being residents, they should have no right to expect any changes, nor request any changes or restrictions whatsoever – just learn to deal with it during their tenure at school. They attend the school about 7 hours a day. We live here year-round. Your considering their request for restrictions is unwarranted and unfounded. You have an obligation to uphold the rights and ordinances of “we the people”. That includes those of us in the unincorporated areas – not just the one taxpayer in Lake County claiming the offense – namely Stevenson High School. The school has always been surrounded by individuals who are honest and hard-working. How friendly are they now being? They aren't, at all.

This proposal shouldn't exist – it was brought about by people not living in the governed area so it has no merit. The only people entitled to an opinion are those that live in the governed area – no one else has any right or say-so. The proposal should be discarded accordingly – as should anyone's opinion outside the governed area. Those within the governed area must learn to abide – or they can move to an incorporated area having the restrictions they desire. Otherwise, they must live with what is allowed in the unincorporated area in which they reside and not complain. Leave well enough alone. We unincorporated neighbors are already courteous and respectful of the school during the school week. Allow us the same freedom that you are so vehemently demanding.

"We just threw up our hands and said 'hell with it,'" said retired pollution board Chairman Jacob Dumelle, long a foe of burning. "It became pretty much a local issue after that."

And communities gradually, grudgingly, came to realize that this quaint old custom was a pretty inconsiderate practice and began to ban it. But a backlash hit in 1990, when a state law designed to conserve landfill space first prohibited the inclusion of yard waste with household trash—several towns acted to repeal their bans while burning partisans gathered the strength to block bans where they were being considered.

Only a double dose of tragedy swung the momentum back again. In November 1991, 14-year-old Margaret Hayden of Algonquin died of an acute asthma attack she suffered during a period when a dense haze of leaf smoke hung over the Fox Valley. Three months later in neighboring Lake in the Hills, on a beautiful, late winter Saturday when many residents were burning their accumulated yard waste, 11-year-old asthma patient Jennifer Tank collapsed in her father's arms and died fighting for breath.

Her parents, Ken and Lola Tank, joined with other parents of asthmatic children along with adults with asthma to form Citizens Against Leaf Burning. The coalition dedicated itself to teaching the public and lawmakers that leaf smoke poses a significant threat—that 42 percent of state residents suffer from lung disease, heart ailments or allergies that are exacerbated by leaf burning, according to the American Lung Association of Illinois, and we all are susceptible to cancer.

"I had threatening letters and phone calls about this," Lola Tank said. "People stopped talking to me because they didn't agree with our fight."

The arguments for burning leaves instead of composting or simply mulching them with a lawnmower are that burning is easier and cheaper for the individual, and that burning has that distinctive, romantic aroma.

But it is the smell of suffering for too many, the smell of thoughtlessness and selfishness. The smell, even, of death.

We must give up burning leaves not only because the law is likely to tell us to, but also because it is the right thing to do, because the memory of Margaret Hayden and Jennifer Tank demands it.

Dear Michelle -

I am in FULL support of the leaf-banning you are presenting on May 9th. My son is a young athlete (4th grade) and, in 5 years, I fully expect him to participate in the wide variety of sports that Stevenson has to offer. In fact, we purchased our home specifically to be in the Stevenson School District. **I urge the Stevenson School Board to support the ban as well to protect our children, their students, and future leaders of America!**

There are several reasons why we would be against leaf-burning during school hours and during after school sports. All of these are documented by the Environmental Protection Agency (<http://www.epa.gov/ttn/atw/burn/leafburn2.html>), a federal agency, with significant research into this issue:

Per the EPA, leaf burning has a negative effect on humans as well as the environment:

Residential Leaf Burning

Q: Why should I be concerned about leaf burning?

A: leaf burning leads to air pollution, health problems, and fire hazards. Each autumn, homeowners across the United States rake up fallen leaves from their lawns. In the past, people routinely took leaves and other yard trimmings to landfills or relied on waste pick-up services for disposal of the leaves. Because of increasingly scarce landfill space, many State and local governments now ban leaves and other yard trimmings from landfills. With this option removed, there is a growing concern that homeowners may be tempted to burn the leaves in their yards.

Q: What types of air pollutants are emitted from burning leaf piles?

A: The open burning of leaves produces particulate matter and hydrocarbons, which contain a number of toxic, irritant, and carcinogenic (cancer-causing) compounds. Leaf smoke also contains carbon monoxide.

Q: What is particulate matter and why is it a health concern?

A: The visible smoke from leaf burning is composed of tiny particles that contain a number of pollutants. If inhaled, these microscopic particles can reach the deepest regions of the lung and remain there for months or even years. Breathing particulate matter can increase the chances of respiratory infection, reduce the volume of air inhaled and impair the lungs' ability to use that air. Particulate matter can also trigger asthma attacks in some people.

Q: What are hydrocarbons and why are they harmful?

A: Hydrocarbons are chemicals that can exist as both gases and solid particles. Because leaves are often moist and burn without proper air circulation, they often burn poorly, producing high levels of hydrocarbons. Some of these hydrocarbons, such as aldehydes and ketones, cause irritation of the eyes, nose, throat, and lungs. A substantial portion of the hydrocarbons in leaf smoke consists of polynuclear aromatic hydrocarbons, some of which are known carcinogens.

Q: What is carbon monoxide and what are its health effects?

A: Carbon monoxide is an invisible gas that results from incomplete combustion, and burning leaf piles are ideal for creating carbon monoxide emissions. Carbon monoxide is absorbed into the bloodstream through the lungs and combines with red blood cells. This reduces the amount of oxygen the red blood cells can absorb and supply to body tissues. Unborn children, newborn infants, smokers, the elderly, and persons with heart and chronic lung disease are more susceptible to carbon monoxide than the general population.

Q: Are there any other reasons homeowners should not burn leaves?

A: Yes. In many communities open burning of leaves is illegal. Furthermore, the total health, financial, and environmental costs of leaf burning can be quite high. These costs include: (1) higher incidences of health problems and increased health care costs; (2) higher incidences of home and forest fires and associated property loss and need for increased fire protection; and (3) the clean-up costs associated with soiling of personal property.

Q: Is there a better alternative for homeowners to dispose of their leaves?

A: Yes! Composting is a safe and environmentally sound method of managing leaves and other yard trimmings. Proper composting does not cause health or fire hazards and, in fact, can be beneficial to gardens and lawns. Composting is a simple process that involves placing yard trimmings and other organic materials in a pile or bin, maintaining adequate moisture, and turning the pile periodically to mix in air. Microorganisms gradually break down the yard trimmings into a humus-like product called compost. Composting can be practical at home or at community operated compost sites. Community-wide programs are already in place in over 2,200 communities in the United States.

ORDINANCE NO. 02-03-05

OPEN BURNING ORDINANCE

WHEREAS, the 92nd General Assembly approved Public Act 92-0762 on August 6, 2002, with an effective date of January 1, 2003, which states in part that a fire protection district may, by ordinance, require that the district be notified of open burning within the district before it takes place; and

WHEREAS, the District must acquire and maintain specialized equipment and provide specialized training to fire department personnel to mitigate the effects of opening burning on the health, safety, and welfare of the District's residents and property, and on the ecological balance of the environment; and

WHEREAS, the Board of Trustees of the Lincolnshire-Riverwoods Fire Protection District have determined that it is in the best interest of the District and its residents to require that the District be notified of open burning within the district before it takes place;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE LINCOLNSHIRE-RIVERWOODS FIRE PROTECTION DISTRICT, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE. The Lincolnshire-Riverwoods Fire Protection District shall be notified of all open burning within the district before said open burning takes place. The notice shall be made in writing or by telephone, and shall be received by the District not less than six hours prior to an open burn.

SECTION TWO. The District shall not require that a permit for an open burn be obtained from the District.

SECTION THREE. The District may extinguish any open burn that presents a clear, present, and unreasonable danger to persons or adjacent property or that presents an unreasonable risk because of wind, weather, or types of combustibles. The unreasonable risk may include the height of flames, windblown embers, the creation of hazardous fumes, or an unattended fire.

SECTION FOUR. Open burns on agricultural land with an area of fifty acres or more may voluntarily comply with the notice provision of this ordinance, but shall not be required to do so.

SECTION FIVE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

Proposal to Restrict Waste Burning

I would like to thank David Stolman, the Lake County Board, The Planning, Building, & Zoning Committee and the Health & Community Services Committee for providing this public meeting regarding the proposal to restrict landscape waste burning.

I would like you to know that I highly support your efforts in having this proposal become a law. The students, staff and faculty of Stevenson High School have felt the effects of the burning for many years. I have personally experienced the effects of smoke from leaf burning, which has entered the school. Especially in the fall months, I have experienced periods of coughing, scratchy throat and itchy burning eyes. The EPA confirms that the carcinogens are emitted into the air when waste burning occurs. The emissions irritate the eyes, nose, throat, lungs causing coughing, wheezing, chest pain, shortness of breath, and sometimes long-term respiratory problems.

The more people I talk to and letters I read, I have discovered that there are devastating effects especially to asthma patients. When my sister experienced her asthma attacks, she had to use a nebulizer. My mom on several occasions has had to stay up all night to make sure she was breathing properly and had to wake her up every 3 hours to give her a treatment. We are lucky; my sister has battled through her asthma attacks. Others are not so lucky, I received an e-mail from one of my old Indian Princess Chiefs, and his best friend when he was in the army lost his daughter to asthma her death was directly related to leaf burning and she died in his arms. I have included a copy in your packet of the Tribune article which talks about the incident. I felt chills when I read the article, because this could possibly happen at Stevenson.

The overwhelming responses I have received from Teachers, Staff and Students has been amazing. I have included in your packet 68 e-mails and letters with heartfelt stories that you should all read. The stories include: The Band Director, Mr. Slepak, who is very concerned about his 350 band students who practice outside especially on days where burning has occurred. The student athlete William Sullivan, who plays basketball and baseball and the smog irritates his lungs. Concerned parents like Mrs. Farkas, Mrs. Giannos, and Mrs. Horwitz, who have children with asthma that are afraid that the smoke inhalation would trigger bronchial spasms and put their children into an asthma attack. Homeowners who live near Stevenson and wish their neighbors would stop burning. Last but not

least the 784 signatures collected with the help of Kalei Sorenson, Ali Castriano, Zack Kozub and Carly Margolin. The petition signatures are from student, staff, and parents that support the Lake County Board and Committees efforts for the restrictive ban on yard waste.

Many letters have requested a complete ban on the burning. I understand that the Board would like to work with the neighbors in this area and if this is not possible then the proposal is a great start to protect the Stevenson Family. However, I would recommend an amendment to the proposal. The amendment would further classify restricting the burning to include outside intramural activities and to include weekends where outside sports events are scheduled. I would also like to add the month of March, since many spring sports practice outside in March.

I sincerely hope that the Lake County Board passes this law so that we at Stevenson High School know that we are safe at school and our parents don't need to worry about us when we are here. Please understand, we feel helpless because we do not have control over the air we breathe and frightened because the air in and around our school could cause cancer, heart and lung diseases.


Please protect us and pass this law.

Leaf-burning limits sought near Stevenson High School

School officials at Lincolnshire's Adlai E. Stevenson High School are asking the Lake County Board to restrict the burning of leaves and other landscape waste near the school, saying the smoke can sometimes be thick enough to affect students inside the building and to require limits on such outside activities as intramurals.

Lake County officials hope to hear comments on the proposal during a public information meeting at 6 p.m. on May 9 at the high school at 1 Stevenson Way.

The proposed restrictions would limit landscape waste and leaf burning to the months of April, May, October and November between the hours of 5 to 7 p.m. on Mondays through Saturdays and from noon to 7 p.m. on Sundays.

Lake County is trying to balance the needs of both the school and neighbors without an outright ban on burning, said Philip Rovang, assistant to the Lake County administrator.

"We know we're not going to make everybody happy, but we're trying for a balanced approach to this issue," Rovang said. Rovang said the limited months and times were arrived at after research on practices in other counties and municipalities in the area.

The issue is a serious one, according to Mark Michelini, assistant superintendent for business for School District 125, which operates the high school. Michelini says of the school's 4,200 students, 700 are asthmatic.

"If someone burns too close, smoke can get sucked into the school's ventilation system," Michelini said. "It's a difficult situation for our students to learn (in) when they're uncomfortable."

Michelle Hannon, a junior at the school, is one of those asking county board members to limit burning. In an email, she said her sister, a freshman, has asthma.

"Smoke (from the burning) enters the school, causing many health issues such as shortness of breath, coughing, wheezing and chest pain for many students and staff," Hannon said.

Michelini said leaf-burning has been an issue for at least 15 years. He added that the school is working with the Lake County Board to begin a conversation with neighbors.

The proposed restrictions would apply only to residents in unincorporated Lake County. The surrounding towns of Lincolnshire, Buffalo Grove and Vernon Hills ban all leaf and landscape waste burning.

Asthma concerns prompt Stevenson High School leaf-burning talk

A Stevenson High School student's concerns about her sister's asthma could lead to leaf-burning restrictions near the sprawling Lincolnshire campus.

More than a year after teen Michelle Hannon started researching the potential dangers of leaf burning and pushing for a ban near her school, Lake County officials are considering adopting some limits on the practice, a traditionally autumnal procedure that's used to dispose of dead leaves in some residential areas.

The proposal would allow burning only in April, May, October and November between 5 and 7 p.m. Mondays through Saturdays and from noon to 7 p.m. on Sundays.

That's outside the hours of most school activities, officials said. Springtime leaf burning would be permitted because some people don't dispose of leaves until after winter ends, said Phil Rovang, the county's planning director.

A public hearing on the matter is set for Monday, May 9.

The proposal is the result of a campaign started by Hannon, now a junior. She took up the cause in early 2010 after smoke from leaves burning at homes near the school caused students in one of her classes to cough.

Leaf smoke consists of tiny particles that can reach lung tissue and cause coughing, wheezing, chest pain and shortness of breath, according to the Solid Waste Agency of Lake County. It also pollutes the environment and creates road and safety hazards, according to the agency.

"I knew if students without asthma had a hard time breathing, then the consequences for people with asthma could be devastating," Hannon, of Long Grove, recalled in an email.

Hannon was particularly worried about her sister, Rebecca, now a freshman at Stevenson. So, with assistance from a school nurse, Hannon began corresponding last year with county leaders about the issue.

"We do not have control over the air we breathe," Hannon wrote in an early letter to county board member David Stolman, who now serves as the panel's chairman. "The Lake County Board needs to protect our children."

The proposal being weighed by the board would only affect residents living in the unincorporated areas near the school. Homes in unincorporated areas elsewhere in the county would not be affected.

Residents who live in the villages bordering the 76-acre campus — Lincolnshire, Buffalo Grove and Vernon Hills — already are forbidden from burning leaves.

Lake County Board member Aaron Lawlor, who leads the panel's health committee, said the proposed limits could address a specific problem without implementing a total ban, a concept that's proved unpopular with the board and county residents.

A countywide ban last was debated in 1999, and the plan was withdrawn before a vote, Rovang said.

"This is an opportunity for us to study the impact of regulating it without going (for) an all-out ban," said Lawlor, a Vernon Hills Republican.

Hannon is excited the plan is moving forward.

"My parents or any parent should not have to worry if their children are safe at school," said Hannon, whose mother, Stephanie, is a former Long Grove trustee.

The May 9 hearing is set for 6 p.m. at Stevenson.

Residents Invited to Comment on a Burning Issue

The Lake County Board invites citizens to comment on proposed limitations on burning yard waste in unincorporated areas.

Citizens will have the chance to weigh in next week on a proposed ban on landscape waste burning near [Stevenson High School](#).

The proposal would restrict burning in unincorporated Lake County to the months of April, May, October and November, beginning after most school functions have ended.

The Lake County Board will hold a public information meeting on the proposal from 6-8 p.m. Monday at Stevenson. Residents can make comments at the meeting, or submit them via email at communications@lakecountyil.gov. The deadline to submit comments is May 20.

Stevenson junior Michelle Hannon is among the proponents of new restrictions. The Long Grove resident explained that smoke produced by nearby residents burning leaves during the school day has impacted students on many levels.

“The smoke on some days is so intense that outside intramural activities have been prohibited,” she wrote in an email. “Other days, the smoke enters the school causing many health issues such as shortness of breath, coughing, wheezing, and chest pains resulting in missed days of school for many students and staff.”

“We would like the [Lake County] board to know that we would like clean air to breathe and that banning the burning of landscape waste during school hours and activities is a great proposal and the best way to achieve this mission,” she continued.

Hannon, who took up the cause more than a year ago, suggests prohibiting leaf burning within 1,000 feet of a school and encouraging residents to find alternatives to burning, including composting or shredding.

Mark Michelini, Stevenson’s assistant superintendent for business, recently told the School Board that there are 700 asthmatics at Stevenson, and another 200 with breathing difficulties. Board members indicated that they won’t take a stand for or against the proposal in advance of the public meeting, District 125 spokesman Jim Conrey said.

Monday's meeting will be held in Stevenson’s testing center. Attendees are instructed to park in lots B or E, and head to Room 1200, just east of the Sports Center.

Leaf-burning limits sought near Stevenson High

School officials at Lincolnshire's Adlai E. Stevenson High School are asking the Lake County Board to restrict the burning of leaves and other landscape waste near the school, saying the smoke can sometimes be thick enough to affect students inside the building and to require limits on such outside activities as intramurals.

Lake County officials hope to hear comments on the proposal during a public information meeting at 6 p.m. on May 9 at the high school at 1 Stevenson Way.

The proposed restrictions would limit landscape waste and leaf burning to the months of April, May, October and November between the hours of 5 to 7 p.m. on Mondays through Saturdays and from noon to 7 p.m. on Sundays.

Lake County is trying to balance the needs of both the school and neighbors without an outright ban on burning, said Philip Rovang, assistant to the Lake County administrator.

"We know we're not going to make everybody happy, but we're trying for a balanced approach to this issue," Rovang said. Rovang said the limited months and times were arrived at after research on practices in other counties and municipalities in the area.

The issue is a serious one, according to Mark Michelini, assistant superintendent for business for School District 125, which operates the high school. Michelini says of the school's 4,200 students, 700 are asthmatic.

"If someone burns too close, smoke can get sucked into the school's ventilation system," Michelini said. "It's a difficult situation for our students to learn (in) when they're uncomfortable."

Michelle Hannon, a junior at the school, is one of those asking county board members to limit burning. In an email, she said her sister, a freshman, has asthma.

"Smoke (from the burning) enters the school, causing many health issues such as shortness of breath, coughing, wheezing and chest pain for many students and staff," Hannon said.

Michelini said leaf-burning has been an issue for at least 15 years. He added that the school is working with the Lake County Board to begin a conversation with neighbors.

The proposed restrictions would apply only to certain unincorporated areas in Lake County near the school. The surrounding towns of Lincolnshire, Buffalo Grove and Vernon Hills ban all leaf and landscape waste burning.

I would like to propose the following ordinance for the Lake County Board's consideration:

"A rule is adopted to prohibit the open burning of leaves within 1000 feet of a school. The ordinance provides that a person who is found in violation of the prohibition of burning leaves within 1000 feet of a school shall be subject to a civil penalty fine."

The passing of this ordinance is very important to the health and safety of the children of Lake County. According to the Environmental Protection Agency (EPA), "The total health, financial, and environmental costs of leaf-burning can be quite high. These costs include higher incidences of health problems and increased health care costs; forest fires and property loss and need for increased fire protection; and the clean-up costs associated with soiling of personal property". The burning of waste especially leaves results in serious problems like air pollution, health problems, and fire hazards. A shift in wind could cause buildings to burn down. The moisture trapped in the leaves causes the leaves to burn slowly and generates small air borne particles of dust and soot. The carcinogens emitted by the burning are carbon monoxide which binds with hemoglobin in the bloodstream and reduces the amount of oxygen in the blood and lungs, hydrocarbons, which irritate the eyes, nose, throat and lungs, and benzo(a)pyrene which is known to cause lung cancer. According to Wisconsin's Department of Natural Resources, these particulates can reach deep into lung tissue and cause coughing, wheezing, chest pain, shortness of breath and sometimes long-term respiratory problems. All this information is frightening, but what is more frightening is that we do not have control over the air we breathe and that the air may cause cancer, heart and lung diseases. The Lake County Board needs to protect our children.

The High School I attend, Adlai E. Stevenson located in Lincolnshire, Illinois, has 4,345 students of which 1,266 have confirmed allergies and 540 have diagnosed asthma according to the school nurse Margaret (Peg) Cucci, RN, MS, NCSN. These statistics emphasize the need and urgency of implementing a ban on leaf burning within a reasonable perimeter of the school. The need is great due to several residents that live next to our school that burn leaves. The smoke on some days is so intense that all outside intramural activities are prohibited and the school staff must rearrange schedules for the 4,345 students. The smell and smoke of the burning leaves enters our school and causes many students to cough, have burning eyes, chest pain, and shortness of breath requiring hundreds of students with asthma to go to the nurse for their inhalers or nebulizer treatments. Many students and staff will miss days from school recuperating from the effects of the smoke and carcinogens in their lungs. The students and staff have no choice but to inhale the toxic air because the school has no

recourse against the property owners adjacent to the school. We need the Lake County Board to take action and ban burning leaves within 1000 feet of a school. My sister will be entering High School in the fall and she has asthma. I am very worried for her health. I am afraid that one day the impact from the smoke could take a child's life, so I am hoping that the Lake County will consider this ordinance so that lives may be saved and the air we breathe can be clean.

I believe the negative consequences of burning leaves provide a clear reason to ban the action; however, many residents will ask the question: What will we do with the leaves if we cannot burn them? There are several solutions: 1. Composting is the most environmentally friendly. The residents need only rake up the leaves and place them in a pile. The pile then turns into soil which can be used as fertilizer in gardens. 2. The leaves can be bagged and picked up by the residents' local garbage service. 3. Some communities offer curb leaf pick-up and the municipality will compost the leaves. 4. The leaves can be directly placed around a garden. 5. People can also shred the leaves using their lawn mower until the pieces are so small they can remain on the lawn. There are so many options other than polluting our air and endangering lives.

Passing this ordinance will stop pollution, keep the air clean, and maintain healthy lungs of over 180,000 students ages 5-18 in Lake County (Lake County Partners 2007 estimates). Please consider passing this ordinance it will make a difference.
