*Presented by Marci Jumisko. Ms. Jumisko spoke about the recent cuts in probation and, as a result, the aggressive cuts in expenses and elimination of programs. Ms. Jumisko reported that as result of lobbies to the State Legislature and the Governor's office, Lake County's allocation was increased by almost \$1.1 million. These additional funds will be used to restore the career path program and dues line item that pays for employee memberships in professional organizations. Bob Zastany expounded on the career path program.*

*Chief Judge Booras reported on lobbying efforts that resulted in the Governor restoring \$1.1 million to our budget. County Administrator Barry Burton advised that Metro Counties will be lobbying to remove Probation funding out of the Administrative Office of the Illinois Court (AOIC) and into the legislative area.*
