COUNTY BOARD EXHIBIT 1A

- Within 45 Days of the Date of County Board Approval of the pending Development Application, the Property Owner shall record covenants in the Lake County Recorder of Deeds against the subject property as follows:
 - a. The Property Owner shall not seek or consent to the annexation of the subject property to any municipality except to the Village of Hawthorn Woods;
 - b. The Property Owner shall not allow video-gaming in the Development;
 - c. The Property Owner shall require each new business in the development to obtain a Change of Use Permit from the Lake County Department of Planning, Building and Development.

These covenants shall run with the land and be binding on the Property Owner's successors and assigns.

- 2. Prior to approval of the Final Development Plan, the applicant shall submit evidence documenting that a water supply provided by the Village of Lake Zurich or other approved source supplied via the St. Peter, Galesville portion of the Cambrian-Ordovician Deep Aquifer shall be available to serve the development (final engineering plans approved, improvements bonded and an IEPA and/or other applicable permit(s) secured, and so equipped as to meet USEPA and State drinking water standards) prior to issuance of any certificate of occupancy for the development.
- 3. Amend the parking structure landscape buffering condition to read as follows:

Parking structures shall be limited to 2 stories; any parking structures oriented to Old McHenry Road shall be visually buffered from the Old McHenry right-of-way <u>and be minimally visible to all other Hawthorn Woods residential properties</u> through additional enhanced screening.

4. A Change of Use Permit shall be required for all new businesses in the development. A Change of Use Permit application in a form substantially similar to the form attached herewith shall be completed by each new business and submitted to the Lake County Department of Planning, Building and Development Department prior to the Department's review of such new business request and issuance of a Certificate of Occupancy for such business.

Dimucci Development: Change of Use Permit Application Form

A Change of Use Permit is required for all new businesses in the Dimucci development pursuant to the County of Lake's conditions of approval for the Dimucci development application (Lake County Zoning Case #'s 3746, 4756). This Change of Use Permit application form shall be completed by each new business and submitted to the Lake County Planning, Building and Development Department prior to the Department's review and issuance of a Certificate of Occupancy for such business.
